### **EXTERNAL AUDITORS' ANNUAL AUDIT COMPLETION REPORT**

### 1.0 Purpose of Report

1.1 To present the External Auditors Annual Audit Completion Report, this is attached at Appendix 1.

### 2.0 Background Information

- 2.1 The external auditor issues an Annual Audit Completion Report (ACR) in compliance with the International Standards on Auditing. The significant findings from the audit are reported in the Annual Audit Completion Report, together with the action taken in respect of these findings. The report also gives the auditor's proposed opinion on the Statement of Accounts.
- 2.2 While the accounts have been substantially audited, final confirmation of an unqualified opinion cannot be concluded until all audited areas are finalised. The remaining elements of audit work are to support the valuation of the Council's PPE, testing the inputs and judgements made by the Council's valuation expert.

### 3.0 Statement of Accounts

- 3.1 The Council's Statement of Accounts for 2020/21 were considered at this Committee on the 29<sup>th</sup> September 2021.
- 3.2 Since that date, further audit work has been undertaken based on the outstanding work identified within the ACR presented to the Committee on that date. Further to this an additional section to the accounts has been added into *Note 4 Assumptions made about the future and other major sources of estimation uncertainty*. The additional text refers to the Covid-19 pandemic and the impact of this on the valuation placed on retail and specific trading assets such as car parks. The valuations that were undertaken during the year that are in scope of the above definition represent £3.5m of the Council's overall £387.2m total of PPE. These assets are therefore reported as being subject to material valuation uncertainty. The impact of this, is that less certainty can be placed upon the valuation of these assets than would normally be the case. The additional text that has been included is:

"The Covid-19 pandemic has impacted on global financial markets and market activity is being impacted in many sectors. Whilst property markets are mostly functioning again, retail and specific trading related assets/sectors such as Car Parks continue to be faced with an unprecedented set of circumstances caused by Covid-19.

Our valuer informs us in their valuation report that there is an absence of relevant/sufficient market evidence for the external valuers to base their judgement and that these are therefore reported as being subject to 'material valuation uncertainty' as set out in VPS 3 and CPGA 10 for the RICS Valuation – Global Standards. The year-end valuations for these assets, which represent £3.5m of the Council's £387.2m total Plant, Property and Equipment balance, therefore have less certainty and should be viewed with a higher degree of caution that what would normally be the case".

- 3.3 Further to this, the ACR makes reference to this and in relation to the audit opinion which is anticipated to include an Emphasis of Matter paragraph. The wording for this is included within Appendix B of the ACR. A similar paragraph was included within the audit opinion for the 2019/20 statement of accounts.
- 3.4 The report confirms that the external auditor anticipates issuing an unqualified opinion, without modification, of the 2020/21 Statement of Accounts.
- 3.5 The reports tabled at the committee on the 29<sup>th</sup> September 2021 approved the Annual Governance Statement and the Statement of Accounts and gave delegated authority to the S151 Officer and the Chairman to sign a revised set of accounts if required, and as such, no further recommendations are necessary from this report.
- 3.6 Once all the audited areas are finalised a supplementary letter and report will be presented to the next committee detailing any further amendments.

### 4.0 **<u>RECOMMENDATIONS</u>** that:-

- (a) the Committee receives the updated External Auditors Annual Audit Completion Report for 2020/21;
- (b) the Committee notes the adjustments to the financial statements set out in the Audit Completion Report.



Section 01: **Executive summary** 

### Principal conclusions and significant findings

The detailed scope of our work as your appointed auditor for 2020/21 is set out in the National Audit Office's (NAO) Code of Audit Practice. Our responsibilities and powers are derived from the Local Audit and Accountability Act 2014 and, as outlined in our Audit Strategy Memorandum, our audit has been conducted in accordance with International Standards on Auditing (UK) and means we focus on audit risks that we have assessed as resulting in a higher risk of material misstatement.

In section 4 of this report we have set out our conclusions and significant findings from our audit. This section includes our conclusions on the audit risks and areas of management judgement in our Audit Strategy Memorandum, which include:

- Management override of controls;
- Valuation of net pension liability;
- Valuation of property, plant and equipment and assets held for sale;
- Valuation and recognition of Covid grants throughout 2020/21.

Section 5 sets out internal control recommendations and section 6 sets out audit misstatements and unadjusted misstatements. Section 7 outlines our work on the Council's arrangements to achieve economy, efficiency and effectiveness in its use of resources.

### Steeus and audit opinion

We have substantially completed our audit in respect of the financial statements for the year ended 31 March 202 At the time of preparing this report there are few areas where work is still in progress and these are summarised at Section 2. We will provide an update to you in relation to any significant matters identified at Section 2 as outstanding through our normal follow up letter.

Subject to the satisfactory conclusion of the remaining audit work, we have the following conclusions:

### Audit opinion

We anticipate issuing an unqualified opinion on the financial statements with an Emphasis of Matter paragraph. Our proposed audit opinion is included in the draft auditor's report in Appendix B.



### Value for Money

Our Value for Money work remains in progress and the results of this will be reported within our Auditor's Annual Report later in the year. At this stage we have not identified any significant weaknesses in relation to the arrangements that the Council has in place to secure economy, efficiency and effectiveness in its use of resources. Further detail on our Value for Money work is provided in section 7 of this report.



### Whole of Government Accounts (WGA)

We have not yet received group instructions from the National Audit Office in respect of our work on the Council's WGA submission. We are unable to commence our work in this area until such instructions have been received.

#### Wider powers



The 2014 Act requires us to give an elector, or any representative of the elector, the opportunity to question us about the accounting records of the Council's and to consider any objection made to the accounts.



## 3. Audit approach

### Changes to our audit approach

We provided details of our intended audit approach in our Audit Strategy Memorandum in July 2021. We have not made any changes to our audit approach since we presented our Audit Strategy Memorandum.

### Materiality

Our provisional materiality at the planning stage of the audit was set at  $\pounds 2.3m$  using a benchmark of 2% of gross operating expenditure. Our final assessment of materiality, based on the final financial statements is  $\pounds 2.1m$  using the same benchmark.

### Use of experts

In our Audit Strategy Memorandum we identified the following experts planned to be used by management in preparing the financial statements, and by ourselves in carrying out our audit. There are no changes to the planned approach or matters arising to report.


## 3. Audit approach

### Group audit approach

The Council's group structure for 2020/21 includes the subsidiaries and associated entities noted below. In the prior year, the Council changed its group boundaries, with the merger of a former wholly owned subsidiary and the establishment of two new entities. The group consists of itself, two wholly owned subsidiary companies and a 50% stake in a single purpose joint venture company and will require to be considered for group accounting and reporting requirements. The Council has consolidated three entities into its Group financial statements, Active4Today Limited, Arkwood Developments Limited (both 100% owned) and RHH Newark Limited (50% owned). In auditing these accounts we needed to obtain assurances over the transactions and balances within the Group relating to the subsidiaries.

Our approach has reflected the size and complexity of the transactions and balances within the subsidiary companies that are consolidated into the Council's Group financial statements. Based on our planning discussions and review of the year's accounts, we did not consider any of the subsidiaries to be significant components. Our plan, based on our understanding and the values reported in the prior year's financial statements was to again obtain assurance from analytical procedures supported by a review of the Council's consolidation processes. We did not need to seek specific assurances over transactions and balances from the component auditors of the subsidiary companies.

We did not identify any significant audit risks for Group accounts purposes in relation to these components.





Section 04: **Significant findings** 

In this section we outline the significant findings from our audit. These findings include:

- our audit conclusions regarding other significant risks and key areas of management judgement outlined in the Audit Strategy Memorandum;
- our comments in respect of the accounting policies and disclosures that you have adopted in the financial statements. We have concluded whether the financial statements have been prepared in accordance with the financial reporting framework and commented on any significant accounting policy changes that have been made during the year;
- any further significant matters discussed with management;
- any significant difficulties we experienced during the audit; and
- modifications required to our audit report

As part of our planning procedures we considered the risks of material misstatement in the Council's financial statements that required special audit consideration. Although we report identified significant risks at the planning stage of the audit in our Audit Strategy Memorandum, our risk assessment is a continuous process and we regularly consider whether new significant risks have arisen and how we intend to respond to these risks. No new risks have been identified since we issued our Audit Strategy Memorandum.

### **Significant risks**

#### Management Description of the risk

# override of controls

In all entities, management at various levels within an organisation are in a unique position to perpetrate fraud because of their ability to manipulate accounting records and prepare fraudulent financial statements by overriding controls that otherwise appear to be operating effectively. Due to the unpredictable way in which such override could occur, we consider there to be a risk of material misstatement due to fraud and thus a significant risk on all audits.

### How we addressed this risk

We addressed this risk through performing audit work over accounting estimates impacting amounts included in the financial statements, testing of journal entries, considering the existence of any significant transactions outside the normal course of business or otherwise unusual.

#### Audit conclusion

Our audit procedures have not identified any material errors or uncertainties in the financial statements, or other matters that we wish to bring to Members' attention in relation to management override of controls.

#### Net defined benefit Description of the risk

Y The Council's accounts contain material liabilities relating to the local government pension scheme. The Council uses an actuary to provide an annual valuation of these liabilities in line with the requirements of IAS 19 Employee Benefits. Due to the high degree of estimation uncertainty associated with this valuation, we determined there was a significant risk in this area.

#### How we addressed this risk

To address this risk we have:

- Critically assessed the competency, objectivity and independence of the Nottinghamshire County Council Pension Fund's Actuary, Barnett Waddingham LLP;
- Liaised with the auditors of the Nottinghamshire County Council Pension Fund to gain assurance that the controls in place at the Pension Fund are operating effectively. This included the processes and controls in place to ensure data provided to the Actuary by the Pension Fund for the purposes of the IAS 19 valuation was complete and accurate;
- Tested payroll transactions at the Council to provide assurance over the pension contributions which were deducted and paid to the Pension Fund by the Council;
- Reviewed the appropriateness of the Pension Asset and Liability valuation methodologies applied by the Pension Fund Actuary, and the key assumptions included within the valuation. This included comparing them to expected ranges, utilising information provided by PWC, the consulting actuary engaged by the National Audit Office; and
- Agreed the data in the IAS 19 valuation report provided by the Fund Actuary for accounting purposes to the pension accounting entries and disclosures in the Council's financial statements

#### Audit conclusion

Our audit procedures identified two immaterial errors in the financial statements, arising from matters reported by the external auditors of the Nottinghamshire Pension Fund in respect of revised pension asset values and investment returns. The impact of these errors, which management have not corrected is reported on page 23.

There are no other matters that we wish to bring to Members' attention in relation to the valuation of the Council's net defined pension liability.

#### Valuation of Description of the risk

property, plant, equipment (land & buildings)

The Council's accounts contain material balances and disclosures relating to its holding of property, plant and equipment, and investment properties with the majority of land and building and investment property assets required to be carried at valuation. Due to high degree of estimation uncertainty associated with those held at valuation, we have determined there is a significant risk in this area.

#### How we addressed this risk

To address this risk we have:

- Critically assessed the Council's valuer's scope of work, qualifications, objectivity and independence to carry out the required programme of revaluations;
- Considered whether the overall revaluation methodologies used by the Council's valuer's are in line with industry practice, the CIPFA Code of Practice and the Council's accounting policies;
- Critically assessed the treatment of the upward and downward revaluations in the Council's financial statements with regards to the requirements of the CIPFA Code of Practice;
- Critically assessed the approach that the Council adopts to ensure that any assets not subject to revaluation in 2020/21 were materially correct; and
- Considered movement in market indices between revaluation dates and the year end in order to determine whether these indicated that fair values have moved materially over that time.

#### Audit conclusion

As set out in section 2, we are finalising our sample testing of valuations and completing our testing in relation to the significant audit risk identified. We will update the Audit and Accounts Committee with the results of our work in this area once concluded.

As in the previous year the Council's valuer has reported their valuations on the basis of a 'material uncertainty' existing at the balance sheet date. We expect, in line with normal practice, to include reference to this disclosure as an 'emphasis of matter' in our audit report and are currently consulting on the form of wording for this. Our draft Auditor's Report at Appendix B includes the 'emphasis of matter' paragraph we expect to include.

The procedures we have undertaken to date has identified a single factual error and a single projected error in the financial statements, both of which are immaterial. The impact of these errors, which management have not corrected is reported on page 23.

There are no other matters that we wish to bring to Members' attention in relation to the valuation of the Council's property, plant and equipment.

### Audit conclusion

Our audit procedures have not identified any material errors or uncertainties in the financial statements, or other matters that we wish to bring to Members' attention in relation to Council's recognition of Covid-19 grants.

### **Qualitative aspects of the Council's accounting practices**

We have reviewed the Council's accounting policies and disclosures and concluded they comply with the 2020/21 Code of Practice on Local Authority Accounting, appropriately tailored to the Council's circumstances.

Draft accounts were received from the Council in June 2021 and were of a good quality.

### Significant matters discussed with management

Significant matters discussed with management during the year include the on-going impact of Covid-19 on the Council's business, including any potential impact on risks of material misstatement. This included the disclosures required regarding the key sources of estimation uncertainty that management has made in preparing the Statement of Accounts. There are no matters that we need to highlight in this report.

### Significant difficulties during the audit

During the course of the audit we have had the full co-operation of management. The audit was again carried out remotely but there were no significant difficulties in carrying out our normal audit procedures and obtaining the audit evidence required to complete the audit.

We continue to work with management to complete any remaining audit work and resolve audit queries and are grating of the co-operation and support provided

### Audit fees

As set out in our Audit Strategy Memorandum, we identified the need for a variation to the published scale fee to take account of several matters. Our current estimate, which remains broadly in line with those indicated within our Audit Strategy Memorandum, is set out below:

- Additional testing as a result of changes arising from increased audit quality expectations involving the work on the valuation of land and buildings and on the local government pension scheme £7,067.
- Additional testing as a result of the implementation of new auditing standards: ISA 220 (Revised): Quality control of an audit of financial statements; ISA 540 (Revised): Auditing accounting estimates and related disclosures; ISA570 (Revised) Going Concern; and ISA 600 (Revised): Specific considerations audit of group financial statements £2,892.
- Additional work as a result of the material valuation uncertainty declared by the Council's valuer £876.
- Additional work in respect of Covid-19 grant income recognition £1,188.
- Additional work in respect of the Council's requirement to produce Group Accounts £3,000.
- Additional work as a result of the new Code of Audit Practice and VFM reporting ongoing with our estimate being at least £8,019 depending on the extent of any risks of significant weaknesses requiring additional work.

We will agree the final fee, and any further variations, with management prior to reporting to the Audit and Accounts Committee.

### Wider responsibilities

Our powers and responsibilities under the 2014 Act are broad and include the ability to:

- issue a report in the public interest;
- make statutory recommendations that must be considered and responded to publicly;
- apply to the court for a declaration that an item of account is contrary to law; and
- issue an advisory notice under schedule 8 of the 2014 Act.

We have not exercised any of these powers as part of our 2020/21 audit.

The 2014 Act also gives rights to local electors and other parties, such as the right to ask questions of the auditor and the right to make an objection to an item of account. No such objections have been raised.

### Modifications required to our audit report

Our draft audit report has not been modified and is set out in Appendix B. However, it should be noted that an Emphasis of Matter paragraph has been included in the auditor's opinion due to the material valuation uncertainty raised by the valuer for specific capital assets.

### Possible delay in the audit certificate

The issue of the Audit Certificate confirms that we have discharged all of our audit responsibilities and that the audit is formally 'closed'. The Audit Certificate would normally be published in our Auditor's Report on the Statement of Accounts. We expect to issue the audit report but delay the issue of the Audit Certificate until the following procedures are complete:

- Value for Money We are yet to complete our work in respect of the Council's arrangements for the year ended 31 March 2021 and expect to report our findings in the 2020/21 Auditor's Annual Report within 3 months of giving our audit opinion. At the time of preparing this report, we have not identified any significant weaknesses in the Council's arrangements that require us to make a recommendation.
- Whole of Government Accounts The NAO has not yet issued its Group Instructions for local authority audits.

We will update the Audit and Accounts Committee when more information is known but at this stage the draft Auditor's Report at Appendix B assumes that we are not able to issue the Audit Certificate at this stage.

## 5. Internal control recommendations

The purpose of our audit was to express an opinion on the financial statements. As part of our audit we have considered the internal controls in place relevant to the preparation of the financial statements in order to design audit procedures to allow us to express an opinion on the financial statements but not for the purpose of expressing an opinion on the effectiveness of internal control or to identify any significant deficiencies in their design or operation.

The matters reported are limited to those deficiencies and other control recommendations that we have identified during our normal audit procedures and that we consider to be of sufficient importance to merit being reported. If we had performed more extensive procedures on internal control we might have identified more deficiencies to be reported or concluded that some of the reported deficiencies need not in fact have been reported. Our comments should not be regarded as a comprehensive record of all deficiencies that may exist or improvements that could be made.

Our findings and recommendations are set out below. We have assigned priority rankings to each of them to reflect the importance that we consider each poses to your organisation and, hence, our recommendation in terms of the urgency of required action. In summary, the matters arising fall into the following categories:

Priority ranking	Description	Number of issues
1 (high)	In our view, there is potential for financial loss, damage to reputation or loss of information. This may have implications for the achievement of business strategic objectives. The recommendation should be taken into consideration by management immediately.	1
2 (medium)	In our view, there is a need to strengthen internal control or enhance business efficiency. The recommendations should be actioned in the near future.	1
3 (low)	In our view, internal control should be strengthened in these additional areas when practicable.	1

## 5. Internal control recommendations

### Significant deficiencies in internal control – Level 1

#### **Description of deficiency**

Per review of internal audit reports for COVID 19 business grants it was noted that two grants of £10,000 each had been paid in error and a further two of £10,000 each had been claimed fraudulently. ## 07. Value for Money

### Approach to Value for Money

We are required to consider whether the Council has made proper arrangements for securing economy, efficiency and effectiveness in its use of resources. The NAO issues guidance to auditors that underpins the work we are required to carry out and sets out the reporting criteria that we are required to consider. The reporting criteria are:

- Financial sustainability How the Council plans and manages its resources to ensure it can continue to deliver its services
- · Governance How the Council ensures that it makes informed decisions and properly manages its risks
- Improving economy, efficiency and effectiveness How the Council uses information about its costs and performance to improve the way it manages and delivers its services

At the planning stage of the audit, we undertake work to understand the arrangements that the Council has in place under each of the reporting criteria and we identify risks of significant weaknesses in those arrangements. Although we describe this work as planning work, we keep our understanding of arrangements under review and update our risk assessment throughout the audit to reflect emerging issues that may suggest significant weaknesses in arrangements exist.

We are still undertaking our work in this area although at this stage we have not identified any significant weaknesses in arrangements.

Where our risk-based procedures identify actual significant weaknesses in arrangements we are required to reprove these and make recommendations for improvement. Where such significant weaknesses are identified, we poort these in the audit report.

The **O**rimary output of our work on the Council's arrangements is the commentary on those arrangements that for **D** part of the Auditor's Annual Report. We intend to issue the Auditor's Annual Report in February 2022.

### Status of our work

We are yet to complete our work in respect of the Council's arrangements for the year ended 31 March 2021. At the time of preparing this report, we have not identified any significant weaknesses in arrangements that require us to make a recommendation, however we continue to undertake work on the Council's arrangements.

Our draft audit report at Appendix B outlines that we have not yet completed our work in relation to the Council's arrangements. As noted above, our commentary on the Council's arrangements will be provided in the Auditor's Annual Report expected to be in February 2022.







### Opinion on the financial statements

We have audited the financial statements of Newark and Sherwood District Council ("the Council) and its subsidiary ("the Group") for the year ended 31 March 2021, which comprise the Council and Group Comprehensive Income and Expenditure Statement, the Council and Group Movement in Reserves Statement, the Council and Group Balance Sheet, the Council and Group Cash Flow Statement, the Council's Collection Fund, the Council's Housing Revenue Account and notes to the financial statements, including a summary of significant accounting policies. As disclosed in note 4 of the financial statements, the Council's value included a specific 'material valuation uncertainty' declaration in their report in respect of the Council's retail and specific trading related and car park assets in this group of assets. The Council states at note 4 that concurrently less certainty and a higher degree of caution should be attached to these assets than what would normally be the case. Our opinion is not modified in respect of this matter.
