3 MINUTES OF THE MEETING HELD ON 14 MARCH 2019

AGREED (unanimously) that the Minutes of the meeting held on 15 November 2018 be approved as a correct record and signed by the Chairman.

4 A COMMUNITY ALCOHOL PARTNERSHIP FOR OLLERTON, BOUGHTON & EDWINSTOWE

The Committee considered the report of the Director – Communities & Environment in relation to the work of the Community Alcohol Partnership (CAP) in Ollerton, Boughton and Edwinstowe (OBE) and its possible expansion into Clipstone. The report also sought a representative from the Committee on the Project Group.

The report set out the aims of the CAP stating that its core activities included: education; enforcement; and business engagement. It highlighted the specific work undertaken in OBE with the latest action plan being appended to the report. The success of the CAP had been recognised locally which had prompted the request from the community of Clipstone to join the OBE Group. It was also reported that there was potential for a CAP to be established in Newark with Members being requested to consider a specific potential area.

The Business Manager, in presenting the report, noted that the OBE CAP continued to succeed in its aims. He also noted that when a new CAP was established it attracted initial funding in the region of £2k and it was therefore suggested that Clipstone establish their own partnership.

The Business Manager updated the Committee on the possible establishment of a partnership in Newark. Inspector Heather Sutton from Nottinghamshire Police had made enquiries as to whether this would be something the Council would wish to consider but it was noted that further work needed to be undertaken to establish the most appropriate area. A Member queried whether the premises outside of Newark Town Centre would be included. The Business Manager advised that work was most undertaken with off-licences to combat underage drinking but that some work was also done with public houses.

AGREED (unanimously) that:

- (a) the establishment of an additional Community Alcohol Partnership to operate in the Clipstone area be supported;
- (b) Councillor Lee Brazier be the Committee's representative to sit on the Ollerton, Boughton & Edwinstowe Community Alcohol Partnership and the Clipstone Community Alcohol Partnership Project Groups; and
- (c) the establishment of a Newark Community Alcohol Partnership be supported in principle.

5 <u>LICENSING MEMBERS TRAINING</u>

The Committee considered the report of the Director – Communities & Environment which informed Members of the planned Licensing Act training scheduled to take place on Wednesday, 3 July 2019.

6 BEST BAR NONE SCHEME

The Committee considered the report of the Director – Communities & Environment in relation to the proposals for the 2019/2020 county wide Best Bar None Scheme.

The report set out the background to the scheme highlighting that the rewards available to licensees who provided good management, a safe and enjoyable environment for customers, discouraging binge drinking and the prevention of alcohol related crime. Paragraph 3 of the report provided information on the Scheme to-date with details of proposed future undertakings listed at paragraph 4.

The Chairman advised that the Scheme was to be launched locally through the Pub Watch Scheme, adding that the Pub Watch was growing in strength with the number of public houses attending increasing.

AGREED (unanimously) that:

- (a) the progress of the Nottinghamshire County Best Bar None Scheme be noted; and
- (b) support be given to the Scheme in 2019/2020.

7 DRINKING IN PUBLIC SPACES

The Committee considered the report of the Director – Communities & Environment which sought Members' approval to undertake a consultation on the designation of a Public Spaces Protection Order (PSPO) in Newark Town Centre to control drinking in the street and to remove controls in other areas of the district.

The report set out the background to the introduction of the Orders in October 2014 under the Anti-Social Behaviour, Crime & Policing Act 2014 and that all the current Designated Public Places Orders (DPPO) be replaced by the PSPOs. It was reported that Newark & Sherwood currently had 14 DPPOs across the district relating to alcohol control. The responses to the initial consultation carried out were highlighted in paragraph 4 of the report which noted that there was not widespread alcohol related anti-social behaviour across the district but that there were some localised 'hot spot' areas, predominantly in Newark Town Centre and that discussions had been held with the Police and Newark Town Council about this matter. Details of the proposals were detailed in paragraph 5 of the report.

In considering the report Members discussed the proposals contained within the report in relation to the possible area to be covered by a PSPO in Newark and whether the removal of the current DPPO in Sutton on Trent would result in drinking in public spaces becoming an issue. In response, the Business Manager advised that the proposal to remove the DPPO in Sutton on Trent was following comment from the Police that they had no evidence of any nuisance in that area. If the order was removed and incidents of nuisance occurred the parish council could apply to have a PSPO put in place but that any request to do so must be supported by evidence. 6

AGREED (unanimously) that

- (a) the proposals listed in paragraphs 5.1 to 5.10 of the report be supported; and
- (b) a consultation period of 6 weeks be agreed.

LICENSING COMMITTEE 5 SEPTEMBER 2019

REVIEW OF PAVEMENT LICENCES IN NEWARK

1.0 Purpose of Report

1.1 To Update Members on the review of Pavement Licences in Newark Town Centre.

2.0 Background Information

- 2.1 In March 2019 Members considered proposals for a review of pavement licences in Newark.
- 2.2 It was agreed that the initial piece of work would be to survey all the premises in the town centre that had an outside seating/eating area.
- 2.3 This survey has now been completed and the results are attached as **Appendix One** (to follow) to this report.
- 2.5 It was also agreed that a small working group would be established to review the findings and look to establish a consistent approach to the conditions that can be applied to any licences issued.
- 2.6 Provisional discussions have taken place with the Town Council and it has been agreed to draft some conditions that may be applicable. A draft of these conditions is attached as **Appendix Two** to this report

3.0 Proposals

- 3.1 It is proposed that a meeting of the Working Group be convened to consider the results of the survey and to consider the draft conditions (subject to any amendment by Members).
- 3.2 The County Council have an established Pavement Licence regime and it is therefore proposed that the Working Group consider the fee structure and the duration of the current County Council licences and seeks some consistency.

Draft Conditions for Outside Drinking/Eating Areas

The outside area must be used soley for the purpose of consuming refreshments and not for any other purpose.

The Street Café area should be used for the service and consumption of food and drink only. There should be no preparation or storage of food or drink outside the premises where there is a risk of contamination. The Street Café must not operate a 'Takeaway' facility. All food/drink consumed in the Street Café area should be ordered and purchased there.

The Issuing Authority (or its Agent) may, if necessary, discreetly mark on the highway the extent of the Pavement Café area to ensure its accurate location.

The Licence will only be granted if planning permission has been obtained, if required.

The Pavement Café Licence only permits tables, chairs, umbrellas and barriers to be placed in the highway. No other items, for example space heaters, are permitted. Furniture must be of high quality, uniform style and should complement the surrounding area. The use of plastic garden furniture or picnic tables will not be permitted. Furniture must be in a clean and serviceable condition at all times.

A barrier approximately 1.0m high incorporating a tapping rail not more than 150mm above the ground must be provided to guide persons safely around the Pavement Café. Barriers must not be permanently fixed to the ground where this is public highway. The barriers shall be designed to resist collapse or movement by being blown over or accidentally stumbled into.

All emergency exits and routes from buildings must be kept clear.

The area upon which the proposed seating and other furniture may be sited ("the Licensed Area") will be defined on a plan attached to the licence and shall be used solely for the purpose of consuming refreshments. No unauthorised obstructions are to be placed in the Licensed Area or on the public highway

The hours of operation shall be specific to the Licence but will not be outside of 9am until 11pm

Furniture and barriers must be removed from the designated area at the end of the working day and shall not be stored on the highway.

It is the responsibility of the Licence Holder to obtain all other consents necessary to extend their business onto the highway including where appropriate, any amendment to their existing liquor licence or change of use consent.

The Licence Holder shall not cause any obstruction or danger to people using the highway. The Licence Holder is responsible for the conduct of people within the Pavement Café, allowing rowdy or unruly behaviour may lead to the withdrawal of the licence.

Noise, disturbance, smells or litter which cause a nuisance to the owners or occupiers of any adjacent premises or to members of the public are not acceptable. Amplified music will not be permitted.

The Licensed Area will be suitably managed by staff to ensure the orderly conduct of customers. Standards of cleanliness and tidiness must be maintained to the satisfaction of the Environmental Health Department of the District/Borough Council.

The layout should consider the need for litter bins or similar receptacles for the deposit of cartons, wrappers, containers or similar and similar discarded items and ensure that where these are provided that they are emptied daily and more often when required. Waste from the holders operations must not be disposed of in the permanent litter bins provided by the District Council/Town Council within the highway, but in bins provided by the applicant inside the licensed area.

The Licence Holder will ensure that the Pavement Cafe is maintained in a clean and tidy condition and they shall take all necessary precautions to prevent the highway from becoming littered as a result of their trading activities

Activities shall be restricted to within the Licensed Area and controlled by the Licensee such that people do not congregate outside the Licensed Area.

The Licence Holder shall not undertake any alterations to the highway surface.

The Licence Holder is required to have valid third party public liability insurance to the value of £5,000,000 for any one incident. This insurance shall be applicable to the Pavement Café area. Evidence of valid insurance shall be made available when demanded by a duly authorised officer of the licensing authority (or its Agent). The Licence Holder is required to produce proof of valid insurance on an annual basis.

The Pavement Cafe Licence does not give, or imply any permission to supply intoxicating liquor in the street.

All necessary items shall be removed from the highway if requested by a police officer, an authorised Council officer or representative of a public utility. These items shall remain off the highway for as long as is required.

The Licence is not a transferable asset.

A minimum clear width of 2.1m in town centres and 1.8m elsewhere must be maintained between the boundaries of the pavement café and the street furniture / kerb line at all times. In a Pedestrianised area there must be at least 3.5 metres of unobstructed space in front of the pavement café so that large vehicles such as delivery lorries and fire appliances can pass. The pavement café shall not obscure sight lines for any highway user, interfere with drainage or conflict with dropped crossings

A copy of the Licence shall be kept on the premises at all times It shall be available for inspection by a Police Officer or a duly authorised Officer of the Licensing Authority (or it's Agent) if required.

Failure to comply with any of the above conditions will result in the Licensing Authority (or its Agent) serving a notice stating what remedial action is required and a timescale for this action. Failure to comply with the notice may result in the Licensing Authority taking action, for which it will recover all reasonable expenses. Failure of the licence holder to comply with any notice may result in the revocation of the licence. The Licensing Authority (or its Agent) will order the immediate removal of the Pavement Café if it presents a hazard, if the Licence Holder fails to respond the Licensing Authority (or its Agent) shall remove the Pavement Café and recover its reasonable costs from the Licence Holder.

The Licensee shall make no claim or charge against the Council in the event of the Equipment being lost, stolen or damaged in whatever way from whatever cause.

The Licence shall run for one year from the date agreed between the Licensing Authority and the Licensee and shall remain in force only for such period of time as the Licensee remains the occupier of the Premises or until withdrawn by the Licensing Authority or surrendered to the Licensing Authority I by the Licensee, subject to annual renewal.

LICENSING COMMITTEE 6 SEPTEMBER 2018

SCHEMELINK FOR PUBWATCH

1.0 Purpose of Report

1.1 To update members on the use of the Schemelink software for the members of Pubwatch within Newark & Sherwood.

2.0 Background

- 2.1 Pubwatch is a voluntary organisation set up to promote best practice. Its aim is to achieve a safer drinking environment in all licensed premises throughout the UK.
- 2.2 In Newark & Sherwood, we have 3 Pubwatch schemes. They are based in Newark, Ollerton and Southwell. Each area meets once a month and discusses issues that affects them and helps the share of information. Newark Pubwatch is well attended with approximately 15 members, Ollerton and Southwell have approximately 11 members each.
- 2.3 Pubwatch meetings consider issues such as problematic customers, licensing issues, previous incidents and how they were handled and up and coming events that may impact on licensed premises.
- 2.4 Traditionally, members of Pubwatch have a book that contains the details of the banned members. These are kept on the licensed premise. Updating these books has been an issue faced by all of the schemes within our area due to data protection restrictions and information sharing.
- 2.5 Schemelink is an app which has been developed as a central point for easier data sharing of data and communication across scheme types for example Pubwatch, shopwatch, unifying online services for members, police and councils.
- 2.6 Features of Schemelink include:
 - Group chat
 - Incident logs, which once submitted are sent through to all members
 - Push notifications
 - Notice board, for sharing information for example, photos of counterfeit notes
 - Ability to poll about a ban rather than wait until the next meeting
 - Banned gallery which includes individual watermarks for members, so if images were shared inappropriately it would be easy to discover who had shared them.
 - Each member can appoint temporary access to others for a period of 24 hours, this would be used for SIA door staff.
- 2.7 In November 2108 the Licensing Committee agreed the following minute:

AGREED (unanimously) that the purchase of 40 annual licences for the SchemeLink App, at a cost of £1,240 for one year only, be supported and approved.

- 2.8 The Schemelink App has now been rolled out to the Pub Watch in Newark and has been well received. So far are there are 20 establishments that have either signed up to use the App or are in the process of activating it. The App has proved really useful in identifying individuals that are breaching Pubwatch and more importantly Criminal Behaviour Orders.
- 2.9 The Pubwatch for Ollerton are now in the process of adopting the use of the Schemelink App.

3.0 **Proposals**

- 3.1 It is proposed to monitor the uptake and use of the app. One of the difficulties encountered has been the quality of the photographs. This is currently being addressed.
- 3.2 The Council's administrator can access usage data and regular checks are being made to assess the use and where the app is not being seen to be used the premises will be encouraged to make more use of it.

LICENSING ACT TRAINING - MANSFIELD

1.0 Purpose of Report

1.1 To provide feedback to Members on the Licensing Act update training provided on 3 July 2019.

2.0 Background

- 2.1 The Nottinghamshire Authorities Licensing Group hosted a training course at the Hostess Restaurant in Mansfield for Officers and Members across the County. The training was organised for the group by officers from Newark & Sherwood. The training covered the following areas of licensing legislation:
 - Basic Introduction to Licensing
 - Licensing Act the Equalities Legislation
 - New Statutory Guidance for Taxis and Private Hire vehicles
- 2.2 This year's training was delivered by a small number of speakers, the main one being Leo Charalambides.
- 2.3 These sessions were delivered to help licensing authorities take a strategic approach to the licensing regime and make the best use of the available powers to deliver a balance between promotion and restraint and help implement best practice.
- 2.4 Not all Members were able to attend and a copy of the notes from the training will be made available to those Members wishing to have them.
- 2.5 The Nottinghamshire Authorities Licensing Group have met since the training and the feedback given was that most of those present thought the training was well delivered and useful to both experienced Members and Members new to licensing.
- 2.6 It is intended to provide additional training for Members next year and any suggestions for topics to be covered can be made to licensing staff who will feed this back to the organising group.
- 2.7 One of the recommendations from the training was that all Members should have access to the Statutory licensing guidance. (known as the 182 guidance). Copies will be made available for each Member of the Committee.

TEMPORARY EVENT NOTICES RECEIVED AND ACKNOWLEDGED BETWEEN 1 APRIL TO 30 JUNE 2019

1.0 Purpose of Report

1.1 To inform Members of changes to Temporary Event Notices and notices that have been received and acknowledged between 1 April and 30 June 2019 inclusive.

2.0 Background Information

- 2.1 The Licensing Act 2003 introduced a light touch system for ad hoc, permitted temporary activities. A Temporary Event Notice (TEN) is given by an individual (a premise user) and authorises the premises user to conduct one or more licensable activities at premises.
- 2.2 There are two types of TEN:
 - A standard TEN, to be given no later than 10 working days before the event to which it relates
 - A late TEN, can be given 9 and not later than 5 working days before the event. Late TENs are intended to be used by premise user who is required for reasons outside their control to for example, change the venue at short notice.
- 2.3 Only the Police and Environmental Health can make representation against the TEN. Once the Police and Environmental Health receive a TEN, they have 3 working days to make any objections to it on the grounds of any of the four licensing objectives: prevention of crime and disorder, prevention of public nuisance, public safety and the protection of children from harm. If no objections are received the event will go ahead as planned. If an objection is received for a standard TEN the Council will have to organise a hearing to consider the objection and may impose conditions or decide that the event cannot go ahead. If an objection is received against a late TEN, no hearing is held and the application is refused.
