NOTED that no Member or Officer declared any interest pursuant to any statutory requirement in any matter discussed or voted upon at the meeting.

The Chairman advised that the proceedings were being recorded by the Council and that the meeting was being livestreamed and broadcast from the Civic Suite, Castle House.

- 15 MINUTES OF THE MEETING HELD ON 22 JUNE 2023
 - AGREED that the Minutes of the meeting held on 22 June 2023 were a correct record and signed by the Chairman.

16 LICENSING FORWARD PLAN (OCTOBER 2023 TO SEPTEMBER 2024)

NOTED the Licensing Committee's Forward Plan from 1 October 2023 to 30 September 2024.

17 STATEMENT OF LICENSING POLICY REVIEW

The Committee considered the report of the Environmental Health & Licensing Manager which sought to present to Members the proposed review of the Statement of Licensing Policy (SoLP) prior to formal consultation taking place.

A copy of the 2024 draft Statement of Licensing Policy was attached as an appendix to the report with a red font having been used to identify where changes were proposed. It was reported that there had been no fundamental changes to any of the policies previously agreed with paragraph 2.3 highlighting the additional information included.

In considering the report, Members agreed that all the additions were to be welcomed and would be of assistance to both the Council and licensees.

A Member queried what support, if any, was given to licensees in order for them to meet all the necessary requirements contained in the SoLP. The Environmental Health & Licensing Manager advised that Licensing Officers were readily available to help both new applicants and existing licensees. They gave advice on the whole process, from how to complete an application form to routine visits to premises to ensure that all the necessary requirements were being adhered to. The Council's Licensing Enforcement Officers were also available to give advice and to work with licensees.

In noting the paragraph detailing safeguarding and children, a Member queried whether there was evidence to suggest that the 'Ask for Angela' initiative was being used. The Environmental Health & Licensing Manager advised that he would liaise with the local Police and provide a written response.

AGREED (unanimously) that:

- a) the draft revision of the Council's Statement of Licensing Policy be approved;
- b) the commencement of the 4-week public consultation be approved; and
- c) the final draft Statement of Licensing Policy, after public consultation, would be returned to the Licensing Committee for approval, prior to adoption at full Council.

18 UPDATE ON PERFORMANCE & ENFORCEMENT MATTERS

The Committee considered the report of the Environmental Health & Licensing Manager which sought to provide Members with the activities and performance of the Licensing Team from 1 April to 30 June 2023.

AGREED (unanimously) that the report be noted.

Report Title	Review of Statement of Licensing Policy - consultee responses	
Purpose of Report	To update Members following the end of the consultation period on the amended Statement of Licensing Policy.	
Recommendations	That this Committees approve the revision and update the Council's Statement of Licensing Policy, recommending adoption by Full Council in December 2023.	

1.0 Background

- 1.1 The Licensing Act 2003 requires the Council to have in place a Policy relating to the carrying out of its functions under that Act. In respect of carrying out its duties the Council is required to adopt and have in place a Statement of Licensing Policy relating to those duties. The Policy sets out the principles which the Council will apply in considering and granting licences under the Act.
- 1.2 The Licensing Act requires the Policy to be reviewed every five years. The current Policy was adopted in January 2019 and therefore needs to be reviewed and adopted before January 2024.
- 1.3 In June 2023 a draft copy of the new Policy was presented to the Licensing Committee and it was agreed that the draft should be released for consultation.

2.0 <u>Responses to the Consultation</u>

- 2.1 The draft copy of the revised Licensing Policy was made available on the web site for a period of 6 weeks. Letters confirming the consultation process and giving details of how to make a response were sent to various the organisations and agencies linked to the licensing trade.
- 2.2 One representation has been received from the Fire Authority. The response is set out in Appendix 1 with suggested amendments to the Policy. There have been no substantial changes made as a result of this consultation response.

3.0 Proposal/Options Considered

3.1 In order to ensure we meet our statutory obligations, the updated Statement of Licensing Policy is required to be in place and agreed by Full Council in January 2024.

Response Following Consultation

Comments made:

Within the draft Licensing Policy 7.11 there is the following paragraph:

"Applicants are expected to have carried out the relevant assessments under other legislation (e.g. fire precautions, health and safety at work, etc) prior to submitting their applications. These assessments should be used to identify particular issues... "

We would like to offer the following alternative for the above:

Alternative:

"Applicants are expected to have carried out the relevant risk assessments under any other relevant legislation (e.g. fire safety, health and safety at work, etc) prior to submitting their applications. These assessments should be used to identify those particular issues..."

We feel the use of the words **fire safety** is more appropriate than fire precautions, and any promotion you can offer towards compliance with fire safety legislation is appreciated and demonstrates enhanced partnership working towards better regulation.

Furthermore any opportunity to promote compliance with other legislation for example fire safety, health and safety etc. would be of benefit.

As an example: but not exhaustive;

a) Within 7.15 is there is an opportunity to have a bullet point similar to "compliance with all appropriate / relevant / applicable** legislation". (delete the ones not required**)

And / or

b) 7.15 - The preparation and application of appropriate risks assessments – may be link this to the suggestion in 7.11 above to highlight fire safety (amongst others).

I have replied with very similar feedback to other licensing draft policies across the county, and I am very encouraged and grateful that a shared suggestion to those authorities appears to have been adopted.

Officer's Response and Recommendation:

The suggested amendment to the wording provides for a more holistic approach to any consideration of our Statement of Licensing Policy and does not increase any regulatory burden. Accordingly, officers recommend that the specific areas highlighted by Nottinghamshire Fire & Rescue Service are amended, as requested.

Report Summary		
Report Title	Update on Pubwatch Schemes currently in operation.	
Purpose of Report	To provide Members with an update on Pubwatch Schemes currently operating in Newark & Sherwood.	
Recommendation	That the report be noted.	

1.0 Background

- 1.1 Pubwatch is a voluntary organisation set up to promote best practice. Its aim is to achieve a safer drinking environment in all licensed premises throughout the UK.
- 1.2 Pubwatch meetings consider issues such as problematic customers, licensing issues, previous incidents and how they were handled, plus up and coming events that may impact on licensed premises.
- 1.3 The Licensing Committee has previously supported the local Pubwatch groups by promoting Schemelink which is a mobile phone app developed as a central point for easier data sharing and communication across Pubwatch for unifying online services for members, the Police and Councils.
- 1.4 Features of Schemelink include:
 - Group chat
 - Incident logs, which once submitted are sent through to all members
 - Push notifications
 - Notice board, for sharing information for example, photos of counterfeit notes
 - Ability to poll about a ban rather than wait until the next meeting
 - Banned gallery which includes individual watermarks for members, so if images were shared inappropriately it would be easy to discover who had shared them.

2.0 <u>Report</u>

2.1 In Newark & Sherwood, we now have four active Pubwatch Schemes. They are based in Newark; Blidworth & Rainworth; Ollerton, Boughton & Edwinstowe (OBE); and Southwell. Each area meets once a month and discusses issues that affects them and helps the share of information.

- 2.2 The meetings in Newark are well structured with good attendance with a lot of information shared within the group. The town centre Police Officer and civilian Police Licensing Officer attend every meeting along with myself and the Chair of the Licensing Committee has expressed a desire to attend the meetings which is always well received by the group.
- 2.3 The Pubwatch group has a positive effect on reducing town centre violence and disorder because of the banning system which varies from 3 months for minor indiscretions to 2 years for serious incidents. Our Licensing Enforcement Officers feel that this has a beneficial impact in keeping Newark a safer place for everyone to enjoy.
- 2.4 Since 2021 a new Pubwatch Scheme has been set up covering Blidworth & Rainworth. In general terms it has been well represented by most of the pubs and clubs from these two villages. Due to constant changes in staff and relatively few incidents they have struggled to embrace the Schemelink app but we continue to promote it as the best intelligence tool for the group. The main success really has been connecting pub managers and staff through Pubwatch and they now have regular contact with each other, not only to pass on useful intel but also to help out one another with their businesses.
- 2.5 With regards to Ollerton, Boughton & Edwinstowe (OBE) Pubwatch, over the last couple of years particularly we have had a strong Chair who also sits on the local OBE Community Alcohol Partnership (CAP) and has been able to contribute towards some excellent results with partners in tackling underage drinking and ASB. This Pubwatch group has also become much better represented and has embraced the Schemelink app, and some serious incidents have been reported and offenders barred from all pubs in the area.
- 2.6 With regards to Southwell Pubwatch, there have been some challenges around representation at the meetings and finding a permanent Chair. We are working hard to get a consistent Chair in place and to encourage and support all local pubs to attend and contribute at the meetings. There are relatively few incidents and similar to the Blidworth & Rainworth Pubwatch, they have struggled to adopt the Schemelink app. More recently at the last 2 meetings there has been an improvement in attendance.

3.0 <u>Proposal/Options Considered</u>

- 3.1 In order to support the local Pubwatch scheme it is proposed that a number of standing agenda items are raised to provide structure to the meetings. However, Pubwatch meetings are not managed by NSDC officers and therefore the agenda items will need to be agreed by the Chair of each meeting.
- 3.2 Members should be aware of all the good work carried out by the Pubwatch Schemes running throughout the Newark & Sherwood area and help promote their activities.

Report Title	Temporary Event Notices received and acknowledged between 1 July until 30 September 2023.							
Purpose of Report	To inform Members of types of Temporary Event Notices and Notices that have been received during the period above.							
Recommendations	That the contents of the report be noted.							

1.0 Background

- 1.1 The Licensing Act 2003 introduced a light touch system for ad hoc, permitted temporary activities. A Temporary Event Notice (TEN) is given by an individual and authorises the premises user to conduct one or more licensable activities at premises.
- 1.2 There are two types of TEN which are:
 - A standard TEN, to be given no later than 10 working days before the event to which it relates; and
 - A late TEN, can be given 9 and not later than 5 working days before the event. Late TENs are intended to be used by premise user who is required for reasons outside their control to for example, change the venue at short notice.
- 1.3 Only the Police and Environmental Health can make representation against the TEN. Once the Police and Environmental Health receive a TEN, they have 3 working days to make any objections to it on the grounds of any of the four licensing objectives:
 - 1. Prevention of crime and disorder
 - 2. Prevention of public nuisance
 - 3. Public safety; and the
 - 4. Protection of children from harm.

If no objections are received the event will go ahead as planned. If an objection is received for a standard TEN the Council will have to organise a hearing to consider the objection and may impose conditions or decide that the event cannot go ahead. If an objection is received against a late TEN, no hearing is held and the application is refused.

1.4 A detailed list of Temporary Event Notices received during the previous quarter is attached at **Appendix A.**
