REVIEW OF STATEMENT OF GAMBLING POLICY

1.0 <u>Purpose of Report</u>

1.1 To seek the Committee's approval of the timetable associated with the review of the Council's Statement of Gambling Policy which the Council is required to review every three years under the Gambling Act 2005.

2.0 Background

- 2.1 The Council, as Licensing Authority under the Gambling Act 2005, is responsible for issuing premises licences for gambling premises, issuing permits in respect of gaming on licensed premises and for registering small society lotteries.
- 2.2 The Council only licences premises on which gambling is carried out, it does not licence the operators or the individuals concerned in carrying the business. These are licensed by the Gambling Commission and subject to stringent statutory controls.
- 2.3 In respect of carrying out its duties the Council is required to adopt and have in place a Statement of Gambling Policy relating to those duties. The Policy sets out the principles which the Council will apply in considering and granting those licences and permits. The original Policy was adopted in December 2006 to come into force on 31 January 2007. Since this time it has been reviewed every three years in line with the statutory requirements. The current Policy was adopted by the Council in January 2016.
- 2.4 The Act requires that the Policy be reviewed as required and at least every three years. Hence the need to review the policy this year so that it can be adopted by 31 January 2019.
- 2.5 A suggested timetable for the review and consultation process is set out below.
