



There have been several serious incidents take place at the premises since the premises licence was granted and the premises was able to open at the end of November 2019, these incidents include at least three occasions of a large fight both inside and outside the premises, drinking glasses used as a weapon, and injuries to customers including a broken jaw; part of an ear being damaged from being bitten, and a fractured cheek bone. Officers also identified on CCTV young adults drinking alcohol that they know to be under the age of 18 years.

Nottinghamshire Police have no confidence in the management to ensure that the licensing objectives are promoted and that they have full control of the premises.

The premises has breached the conditions in place upon the premises licence resulting in written warnings being issued, despite continued support and guidance from Nottinghamshire Police and Newark and Sherwood District Council.

The licensing objectives of the prevention of crime and disorder; public safety; protectionof children from harm, and prevention of public nuisance have all been undermined at this venue.

The premises are situated in Newark Town Centre, with a premises licence that allows the sale of alcohol both on and off the premises, in addition to other licensable activities.

Premises Licence Holder is WAGS Leisure Limited, Companies House shows the sole director of this company to be Gemma Stevens. Gemma Stevens is also the Designated Premises Supervisor and has been since the premise licence was granted in November 2019.

<u>Incidents (not a comprehensive list – All incidents are included in the Police evidence</u> bundle).

23/08/2020 Report – Serious assault on three males victims by approximately 15 other persons inside the premises which lead to it continuing outside. Serious facial injuries sustained and bruising to all victims.

13/08/2020 Report – Caller reports fight outside Madisons, Male went in Madisons was abusive towards staff another patron took him out of Madisons and then there was a fight. Male punched to the face and became unconscious and had heavy bleed from his head.

01/08/2020 Report - Two males arrested for fighting both in and outside of Madisons, one male had part of ear bitten and removed. Due to level of disorder a Section 34 dispersal order was authorised for Newark Town Centre.

18/07/2020 Report —Male disorderly with door staff, officer were outside the premises so ejected the male and arrested him for drunk and disorderly behaviour. Upon searching the male he was found in possession of a knuckle duster and consequently arrested for the same.

04/07/2020 Report - A large fight took place over the duration of 20 minutes, with a person reported being body slammed against a wall and has a dislocated shoulder. Customers within the outside drinking area at the front of the premises assaulted a person in a vehicle, drinking glasses were thrown at the vehicle, at the premises and at other persons leading to a member of staff being injured by a piece of glass within their eye.

01/02/2020 Report – victim reporting he was punched multiple times leading to a bloody nose, states the offenders were staff members as he was telling people the premise were closed.

Visit to Premises.

29/07/2020 K Ansty, Janine Reddish, Pc Harrison, met Gemma Stevens, and Michael Kheng to discuss application to vary the premise licence.

21/07/2020 D Brown Nottinghamshire Police, Tony Gregory Newark and Sherwood Licensing team and Gemma Stevens DPS. Support and Guidance given to DPS.

11/07/2020 K Ansty & D Brown working night time economy, identified breach of SIA

door staff condition as only one was working at that time. Premises closed early. Warning letter was issued.

04/07/2020 – Officers from Newark and Sherwood District Council and Officers from Nottinghamshire Police on a night time economy 'Covid night of action' visited the premises, only one SIA Door Supervisor working.

13/01/2020 Meeting with D Brown & Gemma Stevens to offer support and guidance.

18/12/2020 Meeting with Gemma Stevens, Justin Terry, Wez Ranyard, Kate Ansty and D Brown to discuss future events at the premises, best practice advice and support given.

22/11/2020 K Ansty and D Brown Nottinghamshire Police Licensing working late night economy. Premise visited and spoke to Gemma Stevens, contact details given.

Warning Letters

On 24th August 2020 letter sent addressing an incident that occurred on 4th July 2020, whereby glasses were smashed and used as weapons and breaches of condition identified.

On 11th July 2020 letter sent addressing breach of Door Supervisors condition.

Summary

On 22nd July 2020, the Premise licence holder applied for a variation to extend the hours of their current premise licence and also to remove and replace conditions within Annex 2. On 13th August Nottinghamshire Police submitted a Notice of Representation to Newark and Sherwood District Council apposing to the application in its current form. Due to gathering evidence to submit to the Licensing Panel, it became apparent from looking at incidents in further detail and viewing CCTV that the premises were a greater concern than initially realised.

CCTV footage of incidents clearly shows large disorders taking place were by both staff and customers are placed in a dangerous situation that can cause them great harm, and persons underage have been identified drinking alcohol within the premises.

Due to breaches of licence conditions being identified and incidents taking place, meetings have been held between Gemma Stevens, the Designated Premises Supervisor (DPS) and Police Licensing to highlight areas of concerns, discuss incidents that have occurred and offer solutions and support. The warning letters that have been issued are to formally address the breaches that have been identified, but they also highlight failings in upholding licensing objectives and compliance with the conditions already placed upon Annex 2 of the premise licence.

The majority of the serious incidents have occurred since licensed premises have been able to reopen with Covid restrictions being in place. This has meant Madisons has been operating only using a small part of the premises on a capacity of 50 persons. Nottinghamshire Police are concerned that despite the reduce number of customers social distancing is not taking place within the premises, and serious incidents are still occurring due to poor management and lack of control. Nottinghamshire Police are of the opinion that if Madisons were to operate over a greater capacity and area of the premises, these incidents would only increase which would not only cause a greater risk to the customers visiting the premises, but also be a detriment to the reputation of Newark night time economy.

The Police support premises and encourage well managed, safe premise to thrive.

Nottinghamshire Police have concerns that the management of the premise is undermining the licensing objectives. Gemma Stevens has shown a disregard for advice from Nottinghamshire Police and has continued to operate the premise whilst breaching the premise licence.

Nottinghamshire Police believe in order to rectify the issues surrounding crime and disorder and to ensure the premises is able to fully uphold all four licensing objectives, we would request the Licensing Authority consider the following:

- Reduce times that licensable activities can take place so that they cease at midnight Monday — Sunday with the premises closing 30 minutes after at 0030 hours.
- Remove Gemma Stevens as the Designated Premises Supervisor.
- Add additional conditions to promote best practice:

-Three SIA registered door supervisors shall be on duty on Friday and Saturday evenings from 2000 hours, and if the rear area, the area within the blue line marked on the plan for the premises licence, is open a further two SIA registered door supervisors shall be on duty from 2200 until the premises close. This condition may be disapplied/ amended by written agreement with the Police at least 2 working days prior to the date and time of the disapplication and such written agreement retained at the premises.

- -that those door supervisors are easily identifiable in some sort of uniform and non-casual clothing
- -Consider different SIA Door Supervisors than those current employed.
- That the area of the front of the premises onto the public pavement is covered by a café pavement licence for regulation and control (or by whatever name covers the purpose of a licence known as) issued either by Nottinghamshire County Council or Newark and Sherwood District Council for the placing of tables and chairs to be used by customers.

-for a CCTV camera to be placed covering the area occupied by a café pavement Licence and for it to be recording at all times

A revocation has been considered due to Gemma Stevens being both DPS and sole director of the WAGS Leisure Limited, however, Nottinghamshire Police are confident that if a competent DPS was put in place at the premises, the licence could be complied with. We would not request a revocation at this time, but we do support the Licensing panels decisions for revocation if they wish to make it.

 I am a Police Inspector with Nottinghamshire Police currently based at Newark Police Station, Queens Road, Newark NG24 1LJ. I am the District Commander for the Newark an Sherwood District which includes Newark Town Centre. I have been an officer within Nottinghamshire Police for sixteen years and as a result I am fully conversant with the issues of crime and anti-social behaviour that have been, and continue to be, addressed by partners, stakeholders, the community and those within the policing family. 			
3. As the District Commander I am responsible for managing the policing response to crime and disorder within Newark and Sherwood. This includes identifying crime trends and working with partners across the community safety partnership to set policing priorities. These priorities are set by analysing police incidents and intelligence on a daily basis and comparing these with concerns regularly raised by the local community. It is my aim to set policing strategies that help Nottinghamshire Police to deliver a service that works for local people, with my primary focus being to keep people safe. As a result I have an interest in the operation of all the licensed premises within in the district, particularly those where the sale of alcohol contributes to the high levels of crime, disorder, anti-social behaviour and public nuisance that exist within that and adjacent communities.			
4. Madison's Bar and Bistro, 39A Carter Gate, Newark NG24 1UA is a licenced premise that causes me great concern.

- 5. I consider Madison's to be a risk venue due to the levels of crime and disorder at the location, and also evidence that the staff at Madison's is unable to safely and appropriately manage their venue, within its existing licence conditions. Madison's is one of only four premises within Nottinghamshire County that Nottinghamshire Police has significant concerns around, as is classified as a problem premise.
- 6. As a result of the violent disorder we are currently experiencing within the Newark Night Time Economy, predominantly related to Madison's, I have had to provide a dedicated policing presence every Saturday night, this has included 1 Sergeant and 3 Police Officers from Newark& Sherwood Police Teams, who have been supported by 1 Sergeant and 3 Police Constables from across the force. This is a significant strain on policing resources across Nottinghamshire Police. This in turn has an impact on the level of service we are able to offer to the rest of Newark and Sherwood District.
- Below I have outlined a number of incidents and observations made relating to Madison's, as reported to me by attending officers.
- 8. Saturday 04/07/20- Report from CCTV of disorder at Madison's with approximately 15 persons fighting. On arrival officers dispersed a large, disorderly group. The tables had been thrown over and glass was strewn all over the street. Officers spoke with the DPS regarding safety concerns, who voluntarily closed the premises at 2230 hours. The premises had only one door staff on duty displaying his SIA badge.
 I have viewed the CCTV of the incident and was applauded to see the levels of disorder displayed. There were multiple people fighting, at least three drinking glasses were used as weapons and thrown at people. There was no control by door supervisors. As a result of this incident I am aware a member of bar staff had glass in her eye, a male dislocated his shoulder and other males will have received significant bruising. I have great concern that this incident was not reported by any member of staff at Madison's. This incident has been recorded as a Violent Disorder, crime number 20000343015 and is still under investigation.
- 9. Saturday 18/07/20- Whilst officers were on patrol they witnessed a disturbance outside Madison's. Several groups of people, who appeared to the officers to be overspill from other local licensed premises closing attend Madison's and attempt to push past door staff who denied entry due to being at capacity. There were approximately 30 persons outside, one male was arrested for being drunk and disorderly, and subsequently found to be in possession of offensive weapon. There were two door supervisors on duty at this time, however they were still unable to manage the disorder and needed police intervention. Incident 1069_18072020 and crime number 200000369518 relate to this disorder.

- 10. Saturday 25/07/20- The last premises in Newark Town Centre to close was Madison's, they called last orders around 0115hours and doors were closed at 0200 hours. As other local licensed premises started closing, people began heading towards Madison's and gathered outside as it was at capacity. When officers arrived around 2300hours, the two door supervisors on duty could not say how many persons were inside the premise. They had no system for counting numbers on the door.
 - On viewing the patrons, attending officer's state there appeared to be underage persons inside the premises. When asked, door supervises stated that they had been checking ID's. However, officers located a 17 year old male, known to them, inside the premise. This male did not have any ID on him. I have viewed an image of this male, and he does look like a 17 year old boy. Under the Challenge 25 scheme, I absolutely would expect this male to be asked of identification. Madison's have failed to protect this child on this occasion.

 At 0148 hours the same night, officers again had cause to intervene due to an extremely drunk and disorderly male outside the premise. This male was subsequently arrested. He had been drinking inside the premises immediately before this incident. Incident 0114_26072020 relates.
- 11. Friday 31/07/20- Call made by CCTV operator reporting a disturbance outside Madison's. Officers attended and were met with a large fight outside the premises, with door supervisors struggling to control the situation. Four persons were arrested, one of whom went on to assault a Police Officer. The police van was also contaminated with blood, and was out of service for the following 24 hours. One male suffered a significant injury, where part of his ear had been removed.

As a result of this incident, the Duty Inspector has cause to authorise a Section 34 Dispersal Oder, under the Anti-social Behaviour Act. This gives officers the power to direct persons to leave the area. This has a direct impact on individuals Human Rights and could have a detrimental impact on other surrounding business and the local economy.

This incident was recorded as a public disorder crime under 200000395577 and incident 0111 01082020 relates.

- 12. Saturday 01/08/20- Madison's had to be advised by attending officers to rearrange the setup of their smoking/queueing areas. This worked better for some time, but the queue line barriers were ultimately knocked down during the course of the evening once groups were waiting outside for long periods when premises were at capacity.
- 13. Friday 14/08/20- Licensing check conducted at 2220hours, two door supervisors on duty, who were unable to confirm the numbers of persons within.
- 14. Saturday 15/08/20- Officers attended at closing to manage any disorder. Majority of the customers appeared to be late teens to early twenties. Two door supervisors on duty.

15. **Saturday 22/08/20**- Licensing check conducted at 2200hours. Two door staff on duty, unable to provide accurate number of persons inside. Officers observed persons stood inside the premise, and not seated.

At 02:00 police received a call reporting 15 people were fighting outside Madison's, and comments on the incident log states 'Bouncers struggling to cope.' Officer attendance was delayed due to attending another emergency incident, but on their arrival no fight was located.

A report was received the following day, stating that three male were attacked by approximately 15 other males whilst walking out of Madison's at approximately 0200hours. The victim's sustained injury's that amount to a foot print on one males chest and back, black eye, bruising and disfigurement to the face, fractured jaw and cracked cheekbone. This incident happened in the door way on Madison's and CCTV shows that both the victims and offenders had been Madison customers immediately prior to the attack. This incident resulted in three crimes, GBH 20*440681, ABH 20*440538 and ABH 20*440551, incident 0274_23082020 and 0085_23082020 relates.

16. Saturday 29/08/20- Officers report that Phoenix Security now run the security for most of the public houses in and around Newark Market Place, including Madison's, and this is having a positive impact due to their staff being professional with the appropriate attitude. Officers report evidence of door supervisors at Madison's managing the numbers of customers and clientele well. Door staff were seen to be regularly turning people away and working security effectively. Door staff had counting clickers and therefore had knowledge of the number of people inside. They were under capacity all night; towards the end of the evening they shut their doors despite being under capacity to ensure no more people entered.

At 0027 hours a member of Madison's staff called police to report a disturbance. On officers arrival the situation had calmed down. Incident 0024_30082020 relates.

17. The above shows that the staff at Madison's have no control over the premises and are unable to maintain law and order. They have failed to contact emergency services when crimes are in progress, which if done so early on would have prevented assaults and significant injury to their customers.

Door supervisors have frequently had no knowledge of the number of patrons inside, this is of significant concern, both in the context of their ability to be in control of their premises, but also their ability to keep patrons safe, and allow for social distancing during the coronavirus pandemic.

They have failed to protect children and prevent them from entering their premises.

I have serious concerns that the current licensing conditions are having a negative impact on the community, increasing ASB, crime, disorder and nuisance.

- I am the Senior Licensing Enforcement Officer for Nottinghamshire Police. It is my role to
 engage with the licensed trade and partner agencies to try to reduce alcohol related violence
 and disorder within licensed premises. I have been employed within this role since January
 2018, prior to this, I was the Police Licensing Enforcement officer covering Mansfield and
 Ashfield areas.
- 2. On 11th July 2020 I visited Newark town centre with Daveen Brown, Licensing Enforcement
 Officer. The purpose of the shift was to visit licensed premises and engage with licensee's on
 how they were finding operating since lockdown has lifted. We visited Madisons as part of this
 at approximately 10pm. I noticed on approaching the premises that only one door supervisor
 was present, but I made a guess that there could be another inside the premises. From
 introducing ourselves to staff and speaking with Gemma Stevens she said that they only had
 one door supervisor on duty as that was what their licence permitted. She said that her agent
 had provided a summary for them of what door staff conditions they needed at what times. I
 asked her to present her premises licence so we could go through it together and confirm what
 the condition stated, she did so and we found that two needed to be on duty. I explained that it
 was a breach of her licence and that for her to continue to operate by selling alcohol would be

an offence. I asked her if the door staff company she used had any other doors in the town that she could take a person from so that Madisons would be compliant but she said not. I noticed a male*in the premises that appeared to be door staff so I asked Ms Stevens his name and who he was. She told me his name and brought him over to introduce us as the promotions manager and person who employs the door staff. The male, who's name I do not remember explained he sources door staff from a company that mainly cover premises in Lincolnshire and that he would be unable to get one to come over to Madisons at such short notice and as he didn't have a SIA licence he would be unable to carry out the role himself. I could see Ms Stevens was becoming distressed by the pressure of the situation so I explained to her that myself and Mrs Brown would carry on our patrol visiting some other premises in the locality and would return in approximately 30 mins to find out whether she was deciding to close or was able to resource a SIA door supervisor.

We returned before 11pm to find the venue closing, on the door was the door supervisor and a member of staff, I asked whether the venue was closing and was told by a member of staff that they had closed, I couldn't see Ms Stevens and so after a few minutes we began to walk away to continue with our patrols as we hadn't yet visited all the premises we needed to get to. As we walked away Ms Stevens and Wez Ranyard shouted us for our attention and walked towards us. I could see that both seemed annoyed and upset but under the circumstances this was understandable. They explained that they had closed and had lost money due to this. Ms Stevens said "I THOUGHT YOU SAID YOU WANTED TO WORK WITH US WHY DIDN'T YOU TELL US THAT WE NEEDED TWO DOOR STAFF". Ms Stevens then asked Mrs Brown why she didn't tell them this the weekend previous when she visited and they only had one door supervisor, Mrs Brown explained that although she did work on 4th July, she did not visit Madisons nor Newark Town Centre as it was being patrolled by Newark and Sherwood District Council officers and Police Officers from Newark Police Station. I was of the opinion the both Ms Stevens and Mr Ranyard were placing blame on to us for them closing, I explained that it was an offence for them to knowingly breach their licence conditions and although it wasn't what they wanted to do, by closing early they had made the right decision. I explained that they only have one licence to remember and adhere to and that as a team we have over 1400 licences across the County of Nottinghamshire to enforce so it is not our responsibility as

Police Licensing to know all the conditions upon every licence, and that they needed to take personal responsibility. We then left to continue our visits.

- 4. On 22nd July 2020 Nottinghamshire Police received an application for a variation to the Premise Licence for Madisons. The application requested an extension to times licensable activities can take place and removal of some conditions upon the licence, the premise licence number is 002453. All applications for variations and new licences that are received by Nottinghamshire Police are dealt with by myself as the Senior Licensing Officer, it is my responsibility to consult with applicants and make decisions on whether I feel the proposed variations or new licences will be a detriment to the licensing objections and how they can be managed with licensable activities and conditions.
- 5. I was surprised to receive the variation application for Madisons requesting an extension to the times licensable activities can take place. This is because I had knowledge of incidents of violence and disorder that had taken place at the premises and breaches of the conditions already placed upon the licence. It is rare we receive an application from a premises that is not capable of adhering to the restriction imposed upon their licence. Applications are usually submitted for variation for premises that are promoting best practice and have a limited number of incidents and after discussions with the premises licence holder to consider the proposals prior to the submission of the form.
- 6. On 28th July 2020 I emailed Michael Kheng, the agent for the application on behalf of the applicant, WAGS Leisure Limited to ask for a meeting to discuss the application and its proposals. This meeting was arranged for the following day.
- 7. On 29th July 2020 I visited Madisons along with PC Rob Harrison and Janine Reddish,
 Licensing Administrator. PC Harrison attended as he was familiar with the premises as he
 regularly polices Newark/town centre. Janine attended to take minutes and to gain experience
 in those types of meetings as she was new to the role. At the premise we were met by Gemma
 Stevens (Designated premises supervisor and premises licence holder) and her agent, Michael
 Kheng.
- 8. Once introductions had taken place, I explained that I was surprised to have received the application and asked what had initiated the submission. Michael Kheng explained that it had been prompted by the door staff condition which his client wanted to be dissapplied as it hadn't

already been dissapplied and they felt that a request to do so to Nottinghamshire Police would be denied. I explained that with all premises we liked to see six months of operating to be able to see how a proactively a premise would operate and what impact, if any, there would be within the town centre. It was acknowledged that due to the Coronavirus pandemic, there operating had been disrupted due to being closed for some time of which before they were only able to open for three months. Mr Kheng said they also wanted to be able to open later, and that the main focus was on the Gin bar to enable them to be able to recoup losses by being able to make a profit opening until 4am on a Friday and Saturday, and have more manageable conditions.

Ms Stevens said she wanted to create an identity for the nightclub part of the premise so it was different to the gin bar. Mr Kheng displayed plans which were colour coded into two sections, a blue section detailing the nightclub, and a pink section outlining the gin bar.

- 9. In order to understand the demand and potential risks, I asked Ms Stevens how many people she was holding in the venue pre covid when the premises close at the end of the night. This is important to know for the impact it can have on neighbouring premises and how it will need to be policed. If a lot of people are leaving a premise at closing time it can have a negative effect and lead to disorder. Ms Stevens explained that their busiest time was from midnight until 1.30am with approximately 150 persons.
- 10 I explained that Nottinghamshire Police was not against an application to support a nightclub in Newark, but that we would want it to be appropriately safeguarded through conditions. One of the most important conditions relevant to a nightclub is around having a suitable number of door supervisors working at the premises at the appropriate times. Mr Kheng explained that he wanted the decision around door staff to be managed by a risk assessment that would be completed by Ms Stevens on a rolling basis. I asked Ms Stevens what experience she had of completing risk assessments and was told that she has knowledge of how to complete them as she completes them in her current role at the nursery she works at. Mr Kheng went on to explain that there would be short, medium and long term plans that the risk assessment would cover along with events. He said Saturdays are the busiest and they would look at four to, five door staff on but didn't want a condition stipulating just that.

- 10. We went on to discuss incidents and breaches of licence conditions that had taken place at the premises. Ms Stevens was of the opinion that there had only been one incident take place which was 4th July 2020 and also stated this was the occasion where the licence had been breached by only having one door supervisor on duty. I read out a list of incidents that had been recorded by Nottinghamshire Police and stated that a breach of door staff conditions had also taken place on 11th July 2020 as it was witnessed by myself and colleague, Daveen Brown, It was helpful to have PC Harrison at the meeting as he was able to explain to Ms Stevens how the incidents from Madisons impact on policing as he had attended some of the incidents mentioned. Ms Stevens said she wasn't sure why the incidents escalated once outside and that she had no issues or concerns with her door supervisors. I felt that Ms Stevens thought that if incidents occurred outside the premises then they were not related to Madisons and they didn't have the same level of responsibility, however the incidents that have taken place are directly linked in some way to the premises. I explained I was of the opinion that one door supervisor was not enough to safely and competently manage the gin bar, PC Harrison was in agreement and mentioned that a single door supervisor is not enough to deal with the incidents. We weren't able to collectively agree on a number of door supervisors to satisfy both the safety of customers, prevention of crime and disorder, and the number that Madisons wanted to pay for. I asked Mr Kheng to email me suggested wording of a condition he felt appropriate. This was sent through on 29th July 2020 and is provided for information as CEA01.
- 11. We then discussed the proposed times in the application for the sale of alcohol and closure times and that I would rather see a 3am closure than the proposed time, but that I was also concerned with the times that they currently have due to incidents taking place. Mr Kheng explained the extension for times is mainly for Saturday night as there wasn't as much footfall on a Friday night to justify opening to 4am. It was clear that we wouldn't be able to agree on a time within that meeting. We then left the premises.
- 12. On 28th August 2020 I visited Newark Police station with Daveen Brown to view CCTV from incidents that had taken place outside the premises. I understand the footage to have been captured on a CCTV camera in the street operated by Newark and Sherwood District Council. I was appalled at the level of violence seen in these incidents and lack of intervention and

control from door staff and Mr Ranyard who are all seen on the CCTV at different points. CCTV also shows social distancing measures are not adhered to, customers are not made to sit at their tables as they should be. I was also concerned to see customers regularly seen in groups to walk through a door that has a sign upon it stating 'staff only'. I'm unsure why this door is being used by customers if it is in fact for staff only, if it isn't then I am not aware of any reason why the sign hasn't been removed. From looking at the plans of the premises this door could be used as a route to the toilets, large groups of people are seen continuously going back and forth through this doorway which, in my experience as a Licensing Officer, large groups of males going to the toilets together is usually an indication of drug activity for either the sale or consumption, at this stage I am unable to confirm whether this is a fact at Madisons.

13. After viewing the CCTV with Daveen Brown and PC Harrison, I made the decision that the licensing objections, in particular the prevention of crime and disorder, was severely undermined at Madisons and therefore it was necessary to apply to Newark and Sherwood District Council to review the premises licence; This was allocated to Daveen Brown to complete.

Many thanks for your time today and good to finally meet you.

In regards to the hours applied for my clients would like to retain the hours as applied for, ie until 0400 the day following a Friday and Saturday. As discussed these are hours for the premises to operate within and may not be the actual hours.

In regards to the door supervisor conditions we would like to retain the following as per the application:

On New Year's Eve when the rear area, the area shaded blue on the plan for the premises licence, currently known as Madison's, a minimum of four SIA registered door supervisors shall be on duty from 2200 hrs until the premises close.

In regards to the front lounge bar area, the area shaded red on the plan for the premises licence, currently known as The Lounge Bar and Bistro, the premises licence holder shall ensure that there is an adequate risk assessment of the need for door supervision for the lounge bar and shall provide door supervision, sufficient to control the entry of persons to the premises and for the keeping of order in the premises when they are used for a licensable activity, in accordance with that risk assessment.

And also

The shall be no alcohol supplied for the consumption off the premises in respect of the rear area, the area shaded blue on the plan for the premises licence, currently known as Madison's.

In regards to:

When the rear area, the area shaded blue on the plan for the premises licence, currently known as Madison's, is open, a minimum of two SIA registered door supervisors shall be on duty from 2200 hrs until the premises close.

I propose that we could amend this to:

When the rear area, the area shaded blue on the plan for the premises licence, currently known as Madison's, is open, there shall be provided SIA registered door supervisors as follows:

- A minimum of two SIA registered door supervisors shall be on duty from 2200 hrs until the premises close for the first 150 customers.
- When the capacity reaches 125 customers and it is expected to increase beyond 150 customers, or does increase past 150 customers, an additional SIA registered door supervisor (to make a minimum total of 3 SIA door supervisors) shall be on duty until close.
- When the capacity reaches 225 customers and it is expected to increase beyond 250 customers, or does
 increase past 250 customers, an additional SIA registered door supervisor (to make a minimum total of 4
 SIA door supervisors) shall be on duty until close.
- When the capacity reaches 325 customers and it is expected to increase beyond 350 customers, or does increase past 350 customers, an additional SIA registered door supervisor (to make a minimum total of 5 SIA door supervisors) shall either be on duty until close, or until the capacity reduces to below 350 customers, whichever may be the sooner.

 I am the Police Licensing Enforcement Officer for Newark, Sherwood, Ashfield and Broxtowe areas based at Mansfield Police Station. My role is to monitor incidents and liaise with designated premises supervisors, premises licence holders, Door Supervisors and partner agencies to try to reduce alcohol related violence and disorder incidents within licensed premises. I have been employed in this role since August 2013. I make this statement in respect of an application to review the premises licence at Madisons Bar and Bistro, Cartergate, Newark, Nottinghamshire, NG24 1UA, there are incidents of serious crime and disorder, reports of poor management of the premise and several breaches of their Licensing conditions placed within the premises licence. Madisons Bar and Bistro is subject to a Premises Licence 002453. The licence 			
permits the sale of alcohol for consumption both on and off the premises between the			
hours of 09:00 and 01:30 Sunday to Wednesday, 09:00 and 02:00 from Thursday to			
Saturday. I enclose a copy of the premise licence and plan for reference and refer to

4. As a result of this review application, I went through previous incidents that are			
related to Madisons Bar and Bistro, Cartergate, Newark, Nottinghamshire, between

- 4th July 2020 to 12th October 2020, and include all Police interactions with the premises from 30th November 2019.
- 5. Since the opening of Madisons Bar and Bistro, on 30th November 2019, I have arranged and attended meetings to support the venue together with partners. On opening night 22nd November 2019, I visited the venue with Kate Ansty Senior Licensing Officer and there met Gemma Stevens, we introduce ourselves and I left my business card with all my contact details with my offer of help and support.
- 6. At 11:00 on 18th December 2020 at 11:00 I arranged a meeting with Gemma Stevens, Justin Terry and Wes Ranyard who I was informed were business partners together with Kate Ansty to go through the premise licence and discuss underage events they were looking at hosting. I enclose a copy of these notes which I refer to as exhibit DWB2.
- 7. At 11:00 on 13th January 2020 I arranged a meeting to discuss incidents and any concerns from the Christmas and New Year period. We discussed toilet checks and records of any refusals by door staff at the door. On examination of the door supervisor record the 15 digit numbers identifying the member of door staff were found to be incomplete, I explained the reason these needed to be completed in full and requested that the door staff register be checked regularly. I enclose a copy of brief meeting notes which I refer to as exhibit DWB 3.
- 8. At 21:48 on Saturday 4th July 2020 Police received a call from council CCTV of a fight involving approximately 15 persons. Officers dispersed a large group, and saw that tables and glasses had been strewn over the street. On viewing the CCTV footage a minimum of three glasses seen to be thrown by one offender using them as a weapon, all offenders of this incident have been confirmed by the investigating officer as being customers of Madisons Bar and Bistro. Madisons Bar and Bistro volunteered to close early due to the incident. Officers they were required to remain at the premise to ensure safe dispersal and to stop customers re-entering the venue. There was one door supervisor on duty at this time, which resulted in a breach of the

premise licence. Pc Krawiecki, attending the incident reported the door supervisor was unable to deal with the incident and was more focused in replacing the barriers that had been knocked down. On reading Pc Krawiecki statement he refers to the door supervisors on page one as not having and SIA badge. I believe that he is referring to the door supervisors not displaying their SIA badge on their person, as they are required to do so. After researching Police systems I was not able to find any record of a call to this incident made by a member of Madison's Bar and Bistro staff. I enclose statement from Pc Nelson as investigating officer, which I refer to as exhibits DWB4, Pc Joseph Krawiecki DWB5.

- 9. At 22:05 on Saturday 4th July 2020 Police received a report from East Midlands Ambulance Service (EMAS). At the time of the call they reported dealing with a male who had been body slammed against a wall had bruising and a dislocated shoulder, along with a member of staff with glass in their eye. I enclose a copy of Incident 0890_04072020 provided for reference. I enclose a copy of the Warning letter dated 24th August 2020 for breach of Condition 15, removal of open vessels. I refer to this as exhibit DWB6. I enclose a copy of Incident 0913_04072020 provided for reference. I issued as a result of this incident enclose a copy of a warning letter issued by Newark & Sherwood District Council who also identified breaches of the premise licence. I refer to this as exhibit DWB7. I also include CCTV footage from the Newark and Sherwood District council system showing the disorder outside Madisons Bar and Bistro. I enclose a copy of the CCTV footage of this incident which I refer to as exhibit DWB8. I enclose an email from Gemma Stevens including a copy of the incident on the 4th July dated 8th July 2020. I refer to this as exhibit DWB9
- 7. On 11th July 2020 I was working in the night time economy in the Newark Area together with Senior Licensing Officer Kate Ansty. We visited premises to offer support and guidance on the relaxation of lockdown. On our arrival to Madisons Bar and Bistro we saw a number of people drinking in the outside front pavement area of the venue.

We ascertained that there was only one door supervisor on duty. Kate Ansty spoke to Gemma Stevens, Designated Premise Supervisor (DPS) and asked where the other member of door staff was. Gemma Stevens said, her agent had provided a summary for them of what door staff requirements they needed and what times they were to work. Kate Ansty asked Gemma Stevens for a copy of her licence so we could clarify the matter. Gemma Stevens produced her licence and it clearly showed that there should be two door supervisors on duty. Kate Ansty advised Gemma Stevens to stop serving immediately as she was in breach of her premise licence and she would be committing an offence if she continued to sell alcohol. A male was then introduced to Kate Ansty as the events manager of Madisons Bar and Bistro and they discussed trying to source another member of door supervisors. Kate Ansty advised Gemma Stevens to see if she could obtain another member of door supervisors, from another venue that was due to close; otherwise she would need to close her venue. Kate Ansty said we would return in approximately thirty minutes to give her time to organise this. Approximately 30 minutes later we returned to Madisons Bar and Bistro and were met by customers leaving the venue, a staff member told us they had shut. We began to walk away to continue with our patrol, when Gemma Stevens and Mr Ranyard shouted to us. They approached us and seemed upset about having to close their venue, which is understandable. Gemma Stevens stated that they had lost money due to closing early, and then said to me, "I THOUGHT YOU SAID YOU WANTED TO WORK WITH US WHY DIDN'T YOU TELL US THAT WE NEEDED TWO DOOR STAFF LAST WEEK". I explained that although I did work on the 4th July I did not work within the Newark area, it was the Council Licensing team working together with the Newark Policing teams. Kate Ansty informed Gemma Stevens that we had over 1400 licences to enforce and her licence was her responsibility. We then carried on with our patrol of Newark Town centre. I enclose a copy of the warning letter dated 15th July 2020, I refer to this as exhibit DWB10.

- 8. At 23:42 on Saturday 18th July 2020 Police received a call reporting disorder at Madisons Bar and Bistro, upon officers arrival they witnessed more than 30 persons involved in a disturbance outside. This was believed to be due to an overspill of customers from other licensed premises, who were being denied access to Madisons Bar and Bistro due being at capacity. There were two door staff on duty at this time, but they were unable to manage the disorder and gain control of customers awaiting entry into the premises One male became violent when removed from Madisons Bar and Bistro. He was arrested for drunk and disorderly and found in possession of a knuckle duster. I enclose a copy of Incident 1069_18072020 for reference and copy of statement from Ps 2858 Matthew Ward, which I refer to as exhibit DWB11 and a statement from Pc 2994 Simon Dawson which I refer to as exhibit DWB12, both of whom attended the incident.
- 9. On 21st July 2020 I arranged a meeting at Madisons Bar and Bistro, with Gemma Stevens, Tony Gregory Licensing Enforcement Officer, Newark and Sherwood District Council. In this meeting we discussed the importance of Track and Trace, and the benefits of the use of a body camera together with door supervisor requirements as per their premise licence. I enclose a copy of the email sent to Gemma Stevens complete with her reply; I refer to as exhibit DWB13.
- 10. At 23:00hr on Saturday 25th July 2020 Officers attended Madisons Bar and Bistro, as it was the later venue in Newark Town Centre. Officers observed the queue outside the premise which was believed to be at capacity. Officers stated the door supervisors were unable to say how many customers they had inside the venue, but confirmed they had ID checked customers on entry. Officers located a male known to them inside Madisons Bar and Bistro who was 17 years of age, and he did not have any identification on him at this time. Ps 1867 Mike Taylor referred to this visit in his statement. I enclose a copy of his statement which I refer to as exhibit DWB14.
- 11 At 01:58 on Saturday 1st August 2020 Police received a call from Newark and Sherwood District Council CCTV. They reported a fight taking place outside Madison

Bar and Bistro. All officers were committed at the time of report, and arrived 15 minutes later to find the fight still in progress. Officers were now dealing with a large fight outside the front of the premises. Door supervisors were struggling to deal with the disorder due to the amount taking place. Four persons were arrested for affray, one of which went on to assault a Police Officer. This incident takes place over 15 minutes with numerous fights, and assaults by individuals. One person had part of their ear bitten off and was covered in blood. The Duty Inspector authorised a Section 34 Dispersal Order, under the anti-social Behaviour Act. This gives Officers the power to direct people to leave the area. There is no record on Police systems of a report being received from the staff at Madisons Bar and Bistro, including disorder or the damage to their property. I enclose a copy of Incident 0111_01082020 for your reference. I also provide a copy of the Newark and Sherwood Council CCTV footage, from this incident which I refer to as exhibit DWB15.

- 13. At 13:06 on Thursday 6th August 2020, Police were called to Madisons Bar and Bistro after a report of two people believed to be bailiffs removing goods from the premise. The Police officer attending was informed that this was a payment. I enclose a copy of this incident for your reference 0323_06082020 for your reference.
 - 14. At 19:47 on 13th August 2020 Police received a call reporting a fight outside the front of Madisons Bar and Bistro. A male in the premises became abusive towards the bar staff, resulting in another patron taking him out of the venue due to no door staff present. There was a fight and the male was knocked unconscious for a short while. The male received a head injury. I enclose a copy of incident 0719_13082020 for your reference. I include a copy of Statement from PC 4613 Lauren Carpenter, which I refer to as exhibit DWB16, and a copy of statement from PC 2977 Weston, which I refer to as exhibit DWB17, and a copy of statement from A/PS 3130 Josephine Morris which I refer to as exhibit DWB18.
 - 15. At 02:00 on 23rd August 2020 Police received a call from a male who reported being assaulted and kicked in the back as he went to the door at Madisons Bar and Bistro.

A large fight took place involving many of the customers in front area of Madisons Bar and Bistro, this continued outside of the venue. Three males received a number of serious injuries, including a fractured jaw, and broken cheekbone, black eye, facial bruising and swelling. They also suffered cuts to face and inside their mouth and large areas of bruising to their bodies consistent with being stamped on and repeatedly punched. One male had reddening from the rear of his right ear going down his neck showing what is believed to be a partial pattern of the sole of a shoe. I enclose copy of Incident 0085_23082020 and 0274_23082020 for your reference. I also enclose a statement from Pc 3747 Robert Harrison, which I refer to as Exhibit DWB19, I also enclose a copy of the Newark and Sherwood District Council CCTV and CCTV footage, and footage from inside the front of Madisons Bar and Bistro, I refer to this footage as exhibit DWB20. I am also able to provide a statement from DC 3426 McDonnell officer in charge of the investigation, of incident 0085 23082020, of the 23rd August 2020. DC McDonnell has identified from his enquiries that the body cam footage from the body cam worn by the door supervisor was not made available to assist with the investigation, and that there were only four persons recorded on the track and trace system in place at the time of the incident. This was not an accurate reflection of the correct amount of customers within the premises which was in fact much higher. I refer to this statement as exhibit DWB21. I enclose a copy of the unsigned advice letter regarding not being able to provide the body cam footage of the incident, which I emailed to Gemma Stevens and I refer to as DWB22.

16. At 0027 on 30th August 2020, Police received a report from a door supervisor, working at Madisons Bar and Bistro. The door supervisor reported a fight with a large group of customers and although the incident had calmed down, the problematic customers were still on scene, leading to a decision made by staff that Madisons Bar and Bistro were to close earlier than normal. Officers attended and PC Walsh updated the control room stating the bar staff denied anything had happened.

- 17. At 0003 on 12th September 2020 a report was received from the new door supervisor, at Madisons Bar and Bistro, stating two males are becoming aggressive and have bottles and are threatening to use them on staff. This was identified as a proactive incident by the door supervisor, who had refused entry to two people heavily in drink and in possession of bottles. I enclose a copy of this incident 0003_12092020 for your reference.
- 18. At 0217 on 19th September 2020 a report was received stating there is approximately 20 people arguing and being aggressive and that it had been taking place for 15 minutes. I enclose a copy to this incident 0076_19092020 for your reference. I enclose a copy of a statement from Ps 2858 Ward who attended the incident. I refer to this statement as exhibits DWB23.
- 19. At 21.57 on 26th September a radio message to the control room was received from an Officer requesting for more officers and CCTV to monitor Madisons Bar and Bistro. Officers attended and believed it was an altercation regarding customers not wanting to leave the premises at 2200. I enclose incident number 0812_26092020, which I provide for your reference.
- 20. I enclose a table of other venues in Newark town centre and their closing times, these premises do not report incident of a similar level of violence as Madisons Bar and Bistro which I refer to as exhibit DWB24.
- 21. Nottinghamshire Police, along with partners, have a responsibility to ensure

 Newark Town Centre is not only vibrant, but is an environment that is safe for all
 enjoying the facilities available. Since Madisons Bar and Bistro re-opened on the 4th
 July 2020, we have had a total of 13 incidents reported to the Police requiring
 officers to visit the premises; these include reports of three large scale disorders.

 These incidents record offences of, possession of offensive weapon, drunk and

disorderly, Affray, Public Order, Assault, Actual Bodily Harm and Grievous bodily harm.

22. Police records show that only three of these incidents were reported by staff at the venue. Officers investigating these incidents have highlighted in their statements the difficulty in communication with staff at the venue, obtaining CCTV, body cam footage and other records being available. Only by licensed venues promoting the four licensing objectives, can incidents within licensed premises be reduced. Newark town centre does not benefit from a designated night time economy Police presence, there is also the absence of other night time guardians such as Street Pastors and Street Marshalls that if present, would help to prevent vulnerabilities and prevent crime and disorder. It is therefore more so prevalent that licensed premises actively promote all four of the licensing objectives, and work together with all partners to prevent further demand on emergency services.

Summary

- 23. In my opinion the premises has not been correctly managed. Advice and support has been offered to Gemma Stevens (DPS) and managers to ensure compliance with the conditions upon the premise licence, but breaches have continually taken place leading to enforcement action. In order to rectify the issues surrounding crime and disorder and to ensure the premises is able to fully uphold all four licensing objectives:-
 - Prevention of Crime and Disorder
 - Public Safety
 - Prevention of public nuisance
 - Protection of children from harm

I request the Licensing Authority consider the following:-

Removal of Gemma Stevens as Designated Premise Supervisor.

- Reduction of times that licensable activities can take place so that they
 cease at Midnight Monday Sunday with the premises closing 30
 minutes after at 0030 hours.
- Add the following additional conditions to promote best practice.

 A minimum of three SIA door supervisors to be on duty on the Gin Bar on Friday and Saturday nights, and if the rear area, the area within the blue line marked on the plan for the premise licence, is open a further two SIA registered door supervisors shall be on the duty from 2200until the premises close. This condition may be disapplied/amended by written agreement with the Police 2 working days prior to the date and time of the disapplication/amendment and such written agreement retained at the premises.

Those door supervisors are to be easily identifiable in uniform and not casual clothing.

SIA door supervisors to use a device to ensure capacity complied with.

A minimum of one SIA door supervisors to use a working and recording Body cam, and the footage to be retained for 31 days, and made available to Police on request.

The CCTV system to include the all the outside area used by the venue.

This includes the front and rear smoking area, café pavement area and both entrances.

Ensure that the incident book is used and kept at the premise for 6 months and available for inspection upon request by Police and authorised local authority Officers.

I do not request a revocation at this time, despite the serious nature of some of the incidents and the breaches of the premise licence. However if the panel were to revoke the licence I would fully support this decision. END.

Designated Premises Supervisor

No alcohol may be supplied under this Licence:

- (a) at any time when there is no Designated Premises Supervisor in respect of these Premises; or
- (b) at any time when the Designated Premises Supervisor does not hold a personal licence or his/her personal licence is suspended.

Authorisation By Personal Licence Holders

Every supply of alcohol under this licence must be made or authorised by a person who holds a personal licence.

Irresponsible Promotions

- (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
 - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

Potable Water

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

Age Verification

- (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.

Small Measures

The responsible person must ensure that—

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 - (i) beer or cider: 1/2 pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."

Sales Of Alcohol Below The Permitted Price

(1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

- (2) For the purposes of the condition set out in paragraph 1—
 - (a)"duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
 - (b) "permitted price" is the price found by applying the formula—

$$P = D + (D \times V)$$

where-

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—
- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorizes the supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e). "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994
- (3) Where the permitted price given by Paragraph (b) of paragraph (2) would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- (4) (1)Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day

Door Supervision

Any person exercising a security activity (as defined by paragraph 2(1)(a) of schedule 2 of the Private Security Industry Act 2001) shall be licensed by the Security Industry Authority. Any such person shall be employed at the premises at the discretion of the Licence Holder/Designated Premises Supervisor and shall display their name badge at all times when on duty.

Annex 2 - Conditions consistent with the Operating Schedule

 A CCTV system with recording equipment shall be recorded on the plan appended to the licence. The agreed system shall be installed prior to the premises carrying out licensable activities and maintained.

All recordings used in conjunction with CCTV shall:

- Be of evidential quality.
- Indicate the correct time and date.
- Be retained for a period of 28 days.
- Point of sale to be covered with a camera.
- Ingress and Egress to be covered with a camera.
- Sufficient numbers of staff to be trained to use system.
- Recordings to be made available for inspection when requested by the Police or any other authorised person pursuant to the Data Protection Act 1998.
- A refusals book, or electronic record, shall be kept recording all instances where service
 of alcohol is refused. Records to be retained for at least 12 months and shall be made
 available for inspection to the Police, or other officers of a Responsible Authority, upon
 request.
- There shall be in place the following:
 - -Drugs Policy
 - -Door Supervisor Policy
 - -Search Policy
 - -Dispersal Policy
 - and these polices shall be made available for inspection by a police licensing officer or any person authorised by the licensing authority.
- 4. Two SIA registered door supervisors shall be on duty on Friday and Saturday evenings from 2000 hours, and if the rear area, the area within the blue line marked on the plan for the premises licence, is open a further two SIA registered door supervisors shall be on duty from 2200 until the premises close. This condition may be disapplied/ amended by written agreement with the Police at least 2 working days prior to the date and time of the disapplication and such written agreement retained at the premises.

- 5. A minimum of five suitably trained and licensed SIA door supervisors shall be on duty on Bank Holiday Sunday's, Valentine Day, Boxing day and New Year Eve from 2200 until the premise close.
- A door supervisor to wear and operate a body warn camera with the facility to record footage on Friday and Saturdays from 2000 hours until the premise close unless otherwise agreed in writing with the Police.
- 7. A record/logbook shall be kept on the premises by the Designated Premises Supervisor of every person employed on the premises as a door supervisor. The record shall be retained on the premises for a period of 12 months from date of completion and contain the following details:
 - a) The door supervisor's name;
 - b) His/Her Security Industry Authority licence number;
 - c) The time and date he/she commenced and concluded their duty;
 - d) The door supervisors shall sign each entry; and
 - e) The Designated Premises Supervisor or other authorised person shall also endorse each entry as having checked the authenticity of the individual door supervisor.
- 8. An incident book shall be kept at the premise in which details of crime and/or disorder relating to the premises shall be recorded. The incident book shall contain the following details;
 - a) time, date and location of incident.
 - b) nature of the incident
 - c) names, addresses and contact details of persons involved.
 - d) the result of the incident.
 - e) action taken to prevent further such incidents.
 - f) each entry signed by the DPS or other responsible person employed at the premises and so authorised by the DPS.
- 9. The incident book shall be made available to police upon request. Each entry shall be retained for a period of 12 months from date of completion.
- 10. When live or recorded music is taking place between the hours of 2300hrs and 0800hrs any external windows in areas where live or recorded music is taking place shall be kept closed until the entertainment is no longer taking place, and any door(s) leading from the areas where the regulated entertainment is taking place to outside be closed for the same period save for entry and exit to the premises (NB: this may not in all cases be the last door out of the premises and may be one within a lobby or corridor).

- 11. A Challenge 25 scheme shall be implemented, and a proof of age policy is to be applied with the accepted means of proof of age being:
 - Passport
 - Photo Driving Licence
 - A recognised valid photo-id card bearing the PASS hologram
- 12. Challenge 25 notices shall be displayed in prominent positions throughout the premises.
- 13. Any smoking area(s) must be supervised by a door supervisor from 2200 hours or whilst it is in use by a customer on Fridays and Saturdays until closing.
- 14. No persons carrying open, or sealed, vessels shall be admitted to the premises at any time.
- 15. No persons shall be permitted to remove open vessels from the premises, other than to the designated smoking area at the rear of the premises or customers who may be seated at any tables immediately outside the front of a premises that belong to the premises from opening until 2000 hours on any day of the week.
- 16. For events taking place on a bank holiday weekend, Halloween Weekend and within the month of December ,or any event which is aimed at customer attending under the age of 18, A list of forthcoming events shall be supplied to the police at least 4 weeks prior to the event and shall contain the following information:
 - The timings of the events.
 - The name, address and telephone contact details of the organiser of the event, or hirer of the premises/ part of the premises.
 - The anticipated number of persons attending the event.
 - Any other information requested by the police sufficient to determine whether there is a risk of public disorder.


Where either the management at the premises or the police consider that a forthcoming event has a risk of undermining a Licensing objective, the management at the premises shall, in consultation with the police, undertake a risk assessment. If the police are not satisfied with the management proposals contained in the risk assessment, the event shall not proceed so long as the police have given written notice seven days prior to the date of the event.



The responsibilities of the role are to uphold and promote the four licensing objectives which are:

- Prevention of crime and disorder,
- Public safety,
- Prevention of public nuisance, and
- Protection of children from harm

If a specific premise is falling short in upholding these objectives there can be a negative impact on the rest of the Towns Night Time Economy (NTE). In Newark there are a large number of premises that work hard to keep the public safe. When disorder is present in a Town Centre premise it can have a detrimental effect on the business of other establishments as customers may avoid the Town altogether if they perceive the NTE has the potential to put their safety at risk.

Due to Newark being a small Town the community quickly hear through various methods of any incidents of Disorder that occur in the NTE.

I attend every Pub Watch meeting where incidents are discussed between premises to share information on crime and disorder trends. It was highlighted by several Pub Watch members at the meeting held on August the 27th that there is an issue with Madisons in relation to the level of disorder in the Town.

Since Madisons reopened on the 4th of July 2020 there have been numerous incidents reported to the Police associated with premises and the vast majority of these are violence offences. The worrying part of this though is the level of the violence that has occurred.

The first night of opening, which was the 4th of July 2020, there was a violent disorder, which is still currently being investigated. This incident involved several customers from the pub fighting with each other and on the CCTV one of the offenders

used drinks glasses from the pub as a weapon three times. From viewing the CCTV of this incident I can confirm that all the offenders were drinking at the premises when the incident occurred. This type of disorder is uncommon in a Town like Newark.

On the afternoon of the 2nd of August 2020 I viewed CCTV for an incident that occurred at around 02.00 hours on the Saturday the 1st of August 2020. On this occasion a crime of Affray was recorded and 4 people were eventually arrested with one male having part of his ear bitten off. This incident took place over 15 minutes with numerous fights and assaults by several individuals out on the street. All Officers in Newark were committed at another incident at the time and the incident was discovered by Council CCTV operators. I have searched Police systems and cannot find any record of the staff at Madisons reporting the incident despite the length of time officers were not present and the level of violence. There was also damage caused to property belonging to Madisons during this incident. Staff at all licensed premises have a duty to report violence incidents to the Police as they happen and not rely on CCTV or other customers to report them.

On more than one occasion since the 4th of July 2020 Officers have requested numbers of customers inside from the door staff covering the front of the premises and have been told that they did not know. This would be an issue in normal times but with the current Covid-19 pandemic and the importance of social distancing it poses potential health issues. Door staff need to know how many people are within the premises so they can control the door effectively.

It recent weeks the Police have felt it necessary to have Officers present for the last hour at Madisons to ensure they are in a position to react quickly to any disorder.

that the crowd that was gathered there was too large for the space that was being used and every single person that I spoke to was under the influence of alcohol.

Further to this incident I attended CARTER GATE, NEWARK at approximately 02:30 on Saturday 1st August in relation to reports of a number of males fighting in the street. Prior to my arrival 2 individuals had already been arrested in relation to the incident and I have then arrested a third in relation to the initial fights. The male I have arrested has sustained fairly substantial injuries with blood coming from his face and ear. Although I have arrested the male further down CARTER GATE the male had been seen fighting outside MADDISONS and I believe that he had been inside prior to the incident as one of the other males involved in the incident was ejected from MADDISONS immediately prior to the fighting starting. The male I arrested was clearly intoxicated as I have smelt alcohol on his breath, his speech has been slurred and he was slightly unsteady on his feet.

Whilst attending this incident I arrested a further male for drunk and disorderly. This male was clearly very heavily intoxicated. He was abusive towards the police, he was continually swearing in the street and when told to leave by officers on several occasions did not do so. The male was slurring his speech and was incredibly unsteady on his feet. I also believe that this male had also come from MADDIOSONS as he was a friend of the male who I had arrested a short time before. Out of the people I spoke to on this occasion he was the most intoxicated and at times struggled to remain standing. He was swaying from side to side and needed assistance to walk with a friend putting their arm around him in order to help him remain on his feet.

<u>Warning Letter – Sec 136 Licensing Act 2003</u> Madisons Bar and Bistro, 39A Cartergate, Newark

On 4th July 2020 at 2205 hours, Nottinghamshire Police received a call from East Midlands Ambulance Service reporting an assault at Madisons. The report initially came in as the patient was body slammed against a wall causing a dislocated shoulder and another victim who had glass in her eye. One victim was taken to hospital from treatment.

Officers arrived at your premises to find most of the group involved had dispersed and those that were left did not want to speak to officers to confirm what had happened. As you are aware, Officers obtained CCTV from your premises, and this matter is still under investigation.

I would like to take this opportunity to remind you of Annex 2 condition 15 which relates to vessels being able to leave the premises, I have copied this condition below for your attention:

15. No persons shall be permitted to remove open vessels from the premises, other than to the designated smoking area at the rear of the premises or customers who may be seated at any tables immediately outside the front of a premises that belong to the premises from opening until 2000 hours on any day of the week.

The delay from this incident taking place to this letter is due to the analysis of the CCTV to ensure that the incident and the involvement of the glasses used were directly linked to your venue. We can confirm the glasses were taken from your venue and unfortunately used as a weapon to cause injury. Injury caused by glass is usually permanently visible and often to the face of the victim which is life altering.

The Police are keen to ensure that the possibility of injury in such circumstances is limited and as such I would like to take the opportunity to remind you that there are numerous alternative products on offer that may avoid incidents such as this.

I encourage you to take steps to re train your staff and Door Staff to ensure they understand the condition upon your licence to not allow drinking vessels outside the premises past 2000 hours to prevent them from being used in incidents.

I must advise you that it is an offence under section 136 of the Act if a person carries on or attempts to carry on a licensable activity on or from any premises otherwise than under and in accordance with an authorisation or a person knowingly allows a licensable activity to be so carried on.

In short this means that if you do not comply fully with all of the conditions on your licence, you are liable to prosecution and if found guilty you are liable to imprisonment for a term not exceeding six months, a fine or both.

This letter is deigned to formally warn you of the above matter and request that you take immediate steps to prevent any further incidents occurring.

This letter is to inform you that the Licensing Authority have been made aware of disorder incident on 4th July 2020 at 22:00 at Madisons.

The report from the CCTV control room describes /shows disorder outside the pub with 15 persons fighting. On arrival Police Officers dispersed a large group of people, none of whom wanted to provide any complaints. The tables had been thrown over and glass was strewn all over the street.

The Police have informed us that they spoke with the DPS ref the incident who voluntarily closed the premises at 2230.

The premises had one member of door staff on duty, and although the DPS stated initially that he had three or four on (and included himself in numbers) only one of them was actually displaying his SIA badge.

One member of bar staff ended up with glass in her eye following the disorder and an ambulance was called.

From this incident and your discussion with myself at approx. 19:15 on 4th July 2020, the following licensing breaches have been identified:-

- No café pavement licence is in place (you advised me that you have one with NCC, however, checks with NCC have found that you do not have one)
- Only one SIA door staff was present after 20:00.
- Open vessels were permitted to leave the premises after 20:00.

SERVING PEOPLE, IMPROVING LIVES

I would like to remind you of your licence conditions as below:-

Annex 2 - Conditions consistent with the Operating Schedule

- 4. Two SIA registered door supervisors shall be on duty on Friday and Saturday evenings from 2000 hours, and if the rear area, the area within the blue line marked on the plan for the premises licence, is open a further two SIA registered door supervisors shall be on duty from 2200 until the premises close. This condition may be disapplied/amended by written agreement with the Police at least 2 working days prior to the date and time of the disapplication and such written agreement retained at the premises.
- A minimum of five suitably trained and licensed SIA door supervisors shall be on duty on Bank Holiday Sunday's, Valentine Day, Boxing day and New Year Eve from 2200 until the premise close.
- A door supervisor to wear and operate a body warn camera with the facility to record footage on Friday and Saturdays from 2000 hours until the premise close unless otherwise agreed in writing with the Police.
- A record/logbook shall be kept on the premises by the Designated Premises Supervisor of every person employed on the premises as a door supervisor. The record shall be retained on the premises for a period of 12 months from date of completion and contain the following details:
 - a) The door supervisor's name;
 - b) His/Her Security Industry Authority licence number:
 - c) The time and date he/she commenced and concluded their duty;
 - d) The door supervisors shall sign each entry; and
 - e) The Designated Premises Supervisor or other authorised person shall also endorse each entry as having checked the authenticity of the individual door supervisor.
 - 15. No persons shall be permitted to remove open vessels from the premises, other than to the designated smoking area at the rear of the premises or customers who may be seated at any tables immediately outside the front of a premises that belong to the premises from opening until 2000 hours on any day of the week.

I must advise you that it is an offence under Section 136 of the Licensing Act if a person carries on or attempts to carry on a licensable activity on or from any premises otherwise than under an in accordance with an authorisation or a person knowingly allows a licensable activity to be so carried on.

The Council recognises that businesses need to put in a range of new operating measures to meet the covid secure standard. As a council we are supportive of the night time economy during these COVID 19 times and therefore we would suggest that you:

- Apply for café pavement licence with NCC or NSDC when the new Business and Planning Act 2020 comes into force.
- Apply for a minor variation in relation condition 15. We note that you are required to have 2 SIA door staff and we are happy to discuss this with Nottinghamshire Police with a view to reducing this number if you do not wish to extend the time for the outside area, however, if you do wish to use this area after 20.00hrs then we fully support the condition for 2 door staff as described in condition 4.

- There is a smoking area directly outside the front of the premises which merges into the queuing for entry area. This smoking area is normally crowded and does not appear to be well managed, it is only about 2 metres by 4 metres in size with persons entering it from the premises with no consideration for social distancing.
- MADISONS customers appear to be mostly late teens, door staff have indicated that they check ID but I have not seen this take place.
- Upon closing the customers from MADISONS do not disperse quickly, they will linger on the street outside of MADISONS for periods in excess of 15 to 20 minutes before beginning to disperse. During this period the group makes a considerable noise and provides a flash point for disorder. The make-up of this group is young persons in their late teens many who are intoxicated.
- MADISONS appears to be managed by a male who refers to himself as the "HOST". This male is white aged mid to late 40's, muscular build and about 5 foot 8 inches tall. This male has confirmed that he is not the licence holder. This male though appears to have control over the door staff and the running of the premises. He directs staff including door staff, this has included who to let into the premises and when. Whenever I have attended and am in conversation with door staff this male has immediately approached and taken over the conversation.
- MADISONS due to its relatively small capacity is unable to manage the influx of customers which arrive when other premises close. This causes a large crowd of intoxicated persons to gather in a loose queue outside of the premises. MADISONS is not able to manage this group in an organised queue and it results in the pedestrianised roadway along which vehicles still

this disorder resulted in myself and other officers becoming involved in a violent confrontation with 5 persons from a group of about 30 who were trying to force entry into MADISONS. The level of disorder required other officers to be urgently requested. I was assaulted by one unknown member of the group when he tried to prevent myself and other officers arresting one male. The incident resulted in one male being arrested for a public order offence, when searched he was found to be in possession of a Knuckleduster.

- MADISONS are not reporting incidents. I would expect MADISONS to report incidents of disorder that occur within or outside of the premises. Examples of this include;
 - On Friday 14/8/20 a member of door staff at MADISONS at 0200 hrs
 (closing time) informed me that earlier in the evening he had to eject a violent female.
 - o Saturday 22/8/20 where 3 males were assaulted outside of the premises in view of the door

I am a police constable in the NOTTINGHAMSHIRE police and currently stationed at NEWARK POLICE STATION.

At approximately 2340 hours on 18th July 2020 I attended Madisons Carter Gate Newark Notts on the request of SGT 2858 WARD who was on patrol in the town centre due to the large number of persons congregating outside the premises. I parked my vehicle outside and could see that there was a cordon to the right of the main doors outside the premises which appeared to separate the smoking area of the premises from the pavement. The smoking area appeared to be busy with males and females who appeared in good spirits and outside the main door and smoking area was a large number people who I believed were waiting to get into the premises which I had been told by SGT WARD was full to capacity. There was no evidence of any social distancing being maintained or managed by door staff and I could see that some people had gone under the cordon into the smoking area from the pavement. There seemed to be no control of people outside the main doors which were blocked by people in the smoking area and outside the area which would cause an issue if the premises had to be evacuated quickly and I struggled to see door staff due to the number of people around the

front door. One person left the smoking area with a glass from the premises and I believe door staff wouldn't have even noticed this due to their view being blocked by people outside the front.

My attention was drawn to male who had been causing issues for staff and who I had seen leaving the smoking area carrying a glass in his hand. I was told he was refused entry earlier in the evening but was in the smoking area still. The male was extremely drunk and arrested for public order offences.

In my opinion there was a total lack of management and control of the door and smoking area by door staff and no evidence social distancing was being observed.

There was a single door giving access to the premises, and immediately outside this on the pavement was the designated smoking area that was cordoned off with waist high barriers/banners.

Access to the venue for members of the public waiting was via a roped off entrance within this barrier directly opposite to the door. There was no cohesive queuing system the other side of this barrier, and members of the public were crowded around the barriers to either side of it immediately adjacent to the smoking area.

I asked one of the door security staff what the capacity was and was informed it was 50 persons. When I then asked how many were inside, he was unable to answer and stepped inside to perform a 'head count' before re-emerging and informing me that there were 49 persons inside. There was no on-the-door method in place to count persons in and out (when I suggested a clicker system, I was told that they did have one but it had been left at home).

Door security did not appear to be checking identification (proof of age) for individuals entering, although when asked they stated that they had been doing so (and this did subsequently happen as we were standing there). PC Nicholls, whom I was together with, knew one of the patrons inside the premises and through checks confirmed that he was only 17 years old. This was pointed out to door security and the male was then removed by them from the premises. When PC Nicholls asked him, the male in question claimed not to have any identification with him.

My overall impression of the door security at that time was that they did not have sufficient control over numbers entering, were not effectively checking for age of entrants and the setup of the smoking/queuing area was creating a crowd of people outside that gave potential for spontaneous disorder.

The staffing at NEWARK is very limited and our resources are stretched to deal with other demanding incidents. Since the pubs have reopened in NEWARK, there has been a rise in violent and public order incidents especially in NEWARK TOWN CENTRE. For the past few weeks, there has been a NTE van working Friday and Saturday nights to assist and relieve some of the pressure for response officers. We do not normally have an NTE van working or officers on overtime, so at times we struggle to attend these incidents as well as resource grade one's in NEWARK.

In the past few weeks there have been many violent disorders outside MADDISONS where the Police have attended and dealt with accordingly. The most recent incident I can recall is a robbery and assault which occurred outside MADDISONS on the 23rd August 2020, whereby three males were seriously assaulted and all had injuries. One of the males had a broken jaw and was taken to hospital. This incident happened at approximately 2am which is MADDISON'S current closing time. Officers were unable to resource this incident when this initially came in due to a shortage of officers and all other officers being committed with other incidents.

In my opinion, if MADDISON'S have their license approved to extended their opening times, then officers will be left to deal with the aftermath of further violent incidents. MADDISON'S is currently the latest opening pub and at this time this is the pub we experience the most problems with

I am a Police officer employed by Nottinghamshire Police, based at NEWARK Police Station. At 19:55 hours on Thursday 13 th August 2020 I was double crewed in full uniform and in a marked Police car.
It was around this time that I attended Carter Gate, Newark after I had been made aware that there was a fight happening outside MADDISONS. A call had been passed to our control room from a passer-by who stated that two males were fighting outside the above location. As we arrive on scene we see a male who is unconscious on the floor. The other male involved in the fight was then seen on CCTV to go through the front entrance of MADDISONS. The male who was on the floor in a pool of his own blood as he was bleeding from his head, the male I now know to have the surname
When speaking to staff at MADDISONS they have informed officers that has threatened staff while at the bar. Another person has taken out of MADDISONS where they have started to have a fight, has attempted to throw a punch towards the other male and misses. The male then punches and that is when he is knocked unconscious to the floor. The male is seen on council CCTV running back in to MADDISONS, it is unclear where he goes after this as there are fire exits to the rear with no Council CCTV cover.
I have asked staff if they could tell me the details or a give me a description of the male who has entered the front of the bar and left out the rear exits. None of the staff were able to pass any more information of the suspect who had come through the bar area minutes before our arrival. The staff were keen on telling me what had been saying to them when he was threatening them, but were less forthcoming with information on the male who had passed through their doors. The bar was not busy; there were 2 customers outside and probably 3 more customers inside the bar. When you go in to the bar area there is only 1 exit and you have to pass the bar in order to access this door and I find it hard those 3 members of staff who were behind the bar

On some Friday and Saturday nights we will have a Night Time Economy (NTE) shift that will deal with the town centre, at the moment is an overtime shift for officers at a cost to the force. The NTE shifts have been vital in freeing up the response shift to deal with normal demand. I feel if bars were to be open later this would impact on the force costings but already the daily duties response teams have to deal with. Further to this, on a Friday and Saturday nights we are fortunate that there is a longer grace period between shifts change over from afters to night shifts which only just covers the closing time of MADDISONS as it is now. Any extensions on their license will have an effect on the night shift whose staffing can vary and may not have capacity to cover their own demand and that of licensed premises.

This is the second time in as many weeks that I have had to deal with a job that has been called in, in relation to customers who have been in MADDISONS. The other incident was an affray in which 3 customers were arrested for violent disorder. This disorder occurred at around 2AM, around the time MADDISONS should have been closing, this also resulted in a Police Officer getting assaulted by one of the persons arrested, on viewing the CCTV the door staff struggle to control the situation due to the amount of people on the street and also involved. This fight started outside MADDISONS and then spread further down the street.

At the time of writing this, I am also aware of another large fight which had been called in to our control room at around 2AM which has resulted in 3 people being injured and 1 being admitted to hospital. This again happened outside MADDISONS and we were unable to resource this, due to demand. In my opinion, I feel there have been fewer issues with bars and pubs which close at midnight

MADISONS is the busiest venue within Newark town centre.

I have witnessed persons arriving at MADISONS have clearly already been at other venues and consumed alcohol and are often intoxicated before entering.

I have also witnessed how busy the venue and surrounding streets are upon closing at 0200hrs and how Carter Gate, in particular directly outside MADDISONS, holds large groups of intoxicated persons for some time and this is often a flash point for disorderly behaviour, noise and violence.

Having visited and been involved in a number of incidents both at the premises and outside the premises, I have concerns on the proposed extension of the licensing hours and this is due to the following reasons:

- Upon visiting the premises on Saturday 18th July 2020 a 17 year old male was seen inside the premises consuming alcohol. The male left upon seeing police officers.
- Upon visiting on Saturday 25th July 2020, I asked door staff how many customers were in the venue, due to the current venue capacity being 50 persons and in compliance with COVID19 regulations. Door staff were unable to tell me how many persons were in the venue, therefore it was not clear to them whether the venue was at capacity or not. Door staff commenced a head count and stated 49 customers were present. Prior to the venue closing, several customers outside took part in disorder, resulting in multiple officers having to attend and an arrest was made. A weapon was also found on a person who had been in the venue and a male was arrested.
- Upon visiting on Friday 14th August 2020 door staff confirmed they were at capacity and a queue had formed outside. This queue was loud and mixed with persons smoking directly outside the front door and it was not clear whether door staff had true knowledge of who should and should not be entering the premises.
- Upon visiting on Friday 15th August 2020, door staff were again unable to provide numbers within the venue but was believed to be around 40 persons. Again, not knowing exact numbers and whether the venue was in breach of capacity was of

concern. Persons were seen outside the venue later in the evening consuming alcohol from glasses which had been brought outside the premises.

 Upon visiting the premises on Saturday 22nd August 2020 door staff could again not provide accurate numbers but counted 14 through the window, some of which were clearly questionable in regards to being over 18.

On Monday 24th August 2020 I visited MADISONS and met with the licensees and general manager in regards to a serious incident of violence which had occurred within the premises on Saturday 22nd August at 0200hrs, where 3 males were assaulted, with one male receiving serious injuries.

Upon viewing the CCTV and requesting documentation in regards to the investigation, I have the following concerns:

- CCTV provided showed large scale disorder with three males being assaulted.
 One member of door staff is seen attempting to separate all parties. The second member of door staff stands outside whilst the fight is taking place and only moves inside the premises once the fight spills outside the venue.
- CCTV shows a male I know to be 17 years of age, clearly consuming alcoholic beverages until 0200hrs and whom it would be clear to me would require age verification as per the licence conditions.
- Upon requesting to view the incident log, which should be completed as per the licence conditions, I was informed this had not been completed. The reason for this was due to the fact not all staff had been spoken to yet albeit no details had been recorded despite it being 2 days following the event.
- The door supervisor register was incomplete, with the SIA number of a member of door staff not entered.
- Having viewed CCTV, it is clear social distancing is not taking place, nor
 encouraged or enforced by the venue, with multiple customers mixing in large
 groups and stood despite a seating policy.

Whilst I support any venue within Newark town centre, at this present time I have serious concerns in relation to the extension or alteration of the licence at MADISONS. The venue itself is in a location which I feel is not able to support the large footfall, being some distance from a taxi rank, other venues and take away food, resulting in large gatherings.

On 29th July 2020 I attended a meeting at MADISONS with the Senior Licensing Enforcement Officer for Nottinghamshire Police, Kate ANSTY in which I attended to try and understand the issues at the venue and future plans. It was discussed in this meeting that the venue planned to extend its size, by way opening a night club, increasing the venue capacity. It was discussed that door staff numbers would be based upon a "risk assessment". I raised concerns in relation to the effectiveness of door staff and numbers of door staff being based on a risk assessment and the impact this would have on policing.

I have concerns that the fluidity of Newark night time economy, and a footfall based on other events such as sport or local events would put customers and staff at risk, in that the venue could be under supervised, with violence taking place before the venue is able to react and bolster staff.

In just a matter of weeks, serious violence and disorder has taken place on multiple occasions which has taken place within the venue and outside including persons having bones broken, stamped on and kicked whilst on the floor, a male who had his ear partially bitten off, furniture being picked up and used as a weapon to name a few and being aware and having a vested interest in violent incidents within the town centre, can say the vast majority is at or outside MADDISONS.

Whilst MADISONS cannot solely be blamed for such incidents, it has been increasingly frustrating that door staff have been seen to eject fighting persons and simply closing the door whilst violence continues outside the front door and failing to report incidents to police and each poor practice highlighted contributes towards these incidents.

I can also say that such incidents impact hugely on police resources and as seen at one of the many violent incidents, removes all police resources in the Newark and Sherwood area.

I am police constable 3426 with Nottinghamshire Police, currently based in CID at Newark police station.				
I am currently investigating three assaults which occurred at MADISON'S, CARTER GATE, NEWARK at approximately 02:00 hours on Sunday 23 rd August 2020. Three males were attacked by a group of males inside Madison's. The assaults continued when the victims went outside onto CARTER GATE.				
On 24 th August 2020 PC 3747 Harrison attended Madison's on my behalf to obtain their CCTV footage. Upon reviewing the footage it appeared to me that at the time of the assaults, Madison's was busy with customers. From reading the victim's statements I would infer that the venue was at the maximum capacity allowed, given the current pandemic, since they had to queue outside for half an hour before a table was available. I could see from the footage that there were two door supervisors on duty on the night.				
The assaults occurred near to the front entrance leading onto CARTER GATE. One of the door supervisors was present, and they were able to grab one of the offenders and take them outside. It appeared this door supervisor was wearing a body worn camera as I could see the straps across their back. The door supervisor was assisted by another male who appeared to be a patron as they were not in any sort of uniform. This person assisted in pushing some of the offenders out along with the victim.				
Once the victim had been pushed outside the door was slammed shut. No medical assistance was offered to him given that he had just been repeatedly punched by numerous males. He was now outside with the males who had just assaulted him, and he was again attacked on CARTER GATE by these same males. Having been badly assaulted again there was still no assistance offered by any member of staff from Madison's.

During my policing career it has become my expectation that persons assaulted, or otherwise injured whilst on licensed premises or just outside them, are offered assistance in the form of first aid or an ambulance being called on their behalf.

Instead, what happened here, is that Madison's ejected the victim and effectively left him to fend for himself.

Several days after PC Harrison attended for the CCTV I attended Madison's to enquire as to the body worn camera. I spoke Wes Ranyard, who I understand is one of the owners. I also asked him about obtaining the track and trace information for that night. I left him with my contact details and he assured me he would get back to me. I heard nothing from Madison's until 8th September 2020 when I spoke with Laura Barnett who is employed there as a manager. She informed me that there was no body worn footage during the actual incident. This was put down to it being inadvertently switched off during the scuffle. I asked for the footage captured before and after the camera had been switched as it still may contain evidential footage. Laura explained she would sort this for me, but would require a USB stick to copy the footage to.

I submitted a request to our CCTV processing unit for a USB stick. I travelled to their office in Nottingham city centre to collect it and, on 9th September, I delivered it to Laura at her home address. Laura informed me she would be working at the bar the next few days and would sort the footage for me.

I heard nothing from Madison's until 18th September when I spoke with Laura. On this occasion she informed me that there was no body worn footage at all from that night. She explained that she must have mixed her dates up and thought the incident where the camera was knocked off was from 23rd August, when it must have actually been another occasion.

I attended Madison's that same date and spoke with Wes Ranyard. He sent me an email containing an Excel spreadsheet which had the track and trace data for 22nd to 23rd August. There were only four names recorded. Wes explained that at the time it had not been mandatory for them to obtain track and trace data and they could not force people to provide their details upon entry. He explained that customers were pretending to scan the QR code situated at the entrance to satisfy the door staff they were complying, but then were not completing the process to record their visit. He further explained that they had since changed their track and trace company.

The investigation has been hindered due to the lack of body worn footage, and communication from Madison's could have been much better.

I think it is apparent from the CCTV footage that the sole member of door staff who intervened during the incident struggled with the males, and had it not been for the customer assisting him things could have been worse

ADVICE LETTER

MADISONS, CARTERGATE, NOTTINGHAMSHIRE.

On 23rd August an incident was reported to the police of 3 males being seriously assaulted by a group of males in your venue, and continued outside.

On 24th August Pc 3437 Harrison attended Madisons to obtain CCTV footage including body cam footage, from the body cam worn by the door supervisor on duty at the time of the assault.

Several days later Detective Constable McDonnell spoke to Wes Ranyard to request the body cam footage, and left his contact details. Detective Constable McDonnell made contact again on the 8th September when he spoke to Laura Barnett. Laura requested a USB stick which Dc McDonnell supplied on the 9th September, and was told she would provide in the next few days. On 18th September Detective Constable McDonnell spoke to Laura. On this occasion Detective Constable McDonnell was informed that there was no body worn footage at all for that night.

Detective Constable McDonnell is the lead officer in this violent assault and states that the lack of body worn footage has hindered the enquiry and communication for your venue could have been much better.

On the 15TH July 2020 you received a warning letter, in this letter it reminded your about condition 6 of you premise licence below:-

A door supervisor to wear and operate a body warn camera with the facility to record footage on Friday and Saturdays from 2000 hours until the premise close unless otherwise agreed in writing with the Police.

It is very disappointing that your venue is unable to assist with such a serious incident, and again the footage has been identified as unavailable. I know from previous meetings you informed me that the body cam was the property of the venue and not the door company. I would like to stress that a body cam is a good tool for the prevention and the detection of crime and would ask you ensure the condition on your licence is complied with and in future made available to Officers.
